Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill subjects every risk management pool to the Unfair Insurance Trade Practices Act. The bill provides that risk management pools are prohibited from providing any group self-insurance to its members until the Department of Insurance grants authority to do so with the director's authorization as established by state statute. The bill defines that if the department finds just cause, after notice and a hearing, to not renew a certificate of authority the risk management pool will be dissolved. The bill further states that the director may issue corrective orders in compliance with the Intergovernmental Risk Management Act. If a risk management pool does not comply with a corrective order, the director may remove board members or executive management of the pool.

The Department does not anticipate any fiscal impact as a result of LB1024. While there may be instances where the Department or Director may have to carry out duties outlined in the bill, any such increased duties will be absorbed by existing resources.
