Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill would change evasion of law provisions and ensure certain coverage under the Nebraska Workers' Compensation Act.

It states that when any person lets a portion of a contract to a contractor/subcontractor for work ordinarily done by employees of the person without requiring the contractor/subcontractor to procure a policy of insurance to guarantee payment of compensation to injured workers, the contractor/subcontractor shall be included in the term employee for purposes of the act.

The Workers' Compensation Court, DAS Risk Management (DAS), and the Cities of Imperial and Lincoln estimate no fiscal impact from this bill. DAS notes that all state contracts currently require the contractor/subcontractor to have workers' compensation coverage.
