LB 297 proposes the adoption of the Nebraska Protection of Vulnerable Adults from Financial Exploitation Act. The bill provides that if any broker-dealer, investment advisor, or other person as defined, reasonably believes that financial exploitation of a senior or other vulnerable adult has occurred or is in the process of occurring, notification shall be made to the Adult Protective Services Division of the Department of Health and Human Services and the Department of Banking and Finance. The bill, if enacted, would allow a broker-dealer or investment adviser to take action to prevent financial exploitation, including delaying a transaction or disbursement from an account, and provides administrative and civil protection for qualified persons who are acting in good faith and exercising reasonable care.
