LB265 allows for municipalities without any projects in their clean energy assessment districts to no longer provide a report to the Urban Affairs Committee of the Legislature.

This will change sub-government reporting and any effect of the legislation will be borne by regional governments. Cities of Fremont, Lincoln, and Omaha estimate no fiscal impact as a result of this legislation, and we find no reason to dispute their findings. No fiscal impact on the General Fund.
