LB200 amends §79-729.

Beginning with the 2022-23 school year, each public high school student will complete and submit to the United States Department of Education a Free Application for Federal Student Aid (FAFSA) prior to graduating from such high school.

A public high school student will not be required to comply if:

- A parent or legal guardian of or a person standing in loco parentis to such student signs and submits the appropriate form
 prescribed by the Commissioner of Education indicating that such parent, legal guardian, or person standing in loco parentis
 authorizes such student to decline to complete and submit a FAFSA
- The school principal or the school principal's designee signs and submits the appropriate form prescribed by the Commissioner of Education authorizing such student to decline to complete and submit a FAFSA for good cause as determined by the school principal or the school principal's designee
- A student who is nineteen years of age or older or is an emancipated minor signs and submits the appropriate form prescribed by the Commissioner of Education stating that such student declines to complete and submit a FAFSA.

On or before December 31, 2023, and on or before December 31 of each year thereafter, the Commissioner of Education will electronically submit a report with the information received by the Nebraska Department of Education to the Clerk of the Legislature.

The Fiscal Impact would be minimal at both the state and local levels and can be absorbed by the department and school district.
