LB243 creates the Access College Early Tech Promise Program which would provide financial aid to college students that had been awarded or qualified for Access College Early scholarships for dual credit courses while in high school. The Coordinating Commission for Post-Secondary Education would be responsible for administering the program, and estimates that a 0.5 FTE and related phone (\$30/month) and computer (\$50/month) expenses would be needed to administer the program. In addition to administration expense, it is projected that \$244,000 in Aid would be awarded during 2021-22 and \$406,500 for 2022-23.

Please reference the attached Fiscal Note from the Coordinating Commission for Post-Secondary Education for the complete program description and dollar amounts by expenditure type. The Coordinating Commission states that no funding source has been identified for this program, therefore the Legislative Fiscal Office assumes that the total Operations and Aid expenditures would come from the General Fund.

Current students receiving grants from the Access College Early program in the career and technical education areas of health occupations, information systems/technology, construction, agriculture, welding, automotive technology, and advanced manufacturing were used to estimate the potential number of students in the cost estimate below.

In the first year, 150 students will receive the minimum award of \$1,500 (\$225,000) and 38 of those students whose Pell grant was insufficient to pay all of the tuition and fees will also receive an additional \$500 (\$19,000), for a first year total of \$244,000. In the second and following years, 150 new students will receive a total of \$244,000 as calculated above and 100 students from the previous year will receive the minimum award of \$1,500 (\$150,000) and 25 of those students whose Pell grant was insufficient to pay for tuition and fees will also receive an additional \$500 (\$12,500), for a second year total of \$406,500 (\$244,000+\$150,000+\$12,500).

No funding source has been identified for this program, therefore only the total amount is included above.
