LB 824 makes changes to state statutory laws to do three things: firstly, adding "bathing" to the list of activities of daily living that are considered "care"; secondly, adding "bathing" to the list of activities of daily living that are considered "attendant services"; thirdly, adding "bathing" to the definition of activities of daily living and removing "bathing" from the definition of "personal care."

LB824 appears to simply expand the permitted scope of services that certain non-licensed healthcare professionals can provide. The Department is not able to ascertain any fiscal impact that would occur as a result of the proposed changes to the Health Care Facility Licensure Act, In-Home Personal Services Act, or the Home Health Aide Services Act.
