## **EXPENDITURES:**

The Nebraska Department of Correctional Services (DCS) estimates no fiscal impact to the state. The Supreme Court estimates an increase in judicial workload in some counties, but the extent is undeterminable at this point in time.

The Lancaster County Department of Corrections estimates expenses ranging from \$28,125 to \$112,500 annually to cover the expenses of staff time and transportation to the hearings.

Other cities & counties were unable to respond to the fiscal note request in the allotted timeframe, however it is anticipated that they could have increased expenditures as well.
