LB 785 changes provisions related to early voting ballots.

The bill's provisions change the number of days prior to an election that ballots shall be mailed. Current statute calls for mailings at least 35 days prior to an election. LB 785 calls for mailing "not sooner than 22" days prior to an election.

The Secretary of State estimates no fiscal impact.

The Lancaster County Election Commissioner estimates that the bill's provisions may result in the need for overtime payments.

There is no basis to disagree with these estimates.
