## Explanation of Estimate:

LB 961, as drafted, would appropriate \$4 million in federal funds from the State of Nebraska's Coronavirus State and Local Fiscal Recovery Fund allocation to the University of Nebraska to provide support to the National Counterterrorism Innovation Technology and Education Center (NCITE) at the University of Nebraska at Omaha (UNO). This \$4 million appropriation will build upon the State of Nebraska's investment in NCITE by creating state-of-the-art labs that would, in coordination with the federal recovery fund use rules, enhance workforce development capabilities to build on cutting-edge visualization technology to better depict relationships among bad actors and potential criminals.

Department of Homeland Security has significant workforce needs for current and future employees in Nebraska and across the country, including:

1) Adding capacity to help existing law enforcement and security workforces prevent and respond to violence, as specified by enhancing technology and equipment to support the law enforcement response.

2) Growing the future workforce by tapping UNO's diverse student body, which was impacted by the pandemic. UNO's 2021-22 freshman class is 34% Pell Grant eligible, 38% nonwhite, and 44% first generation. And over 1 in 4 freshmen came from the Omaha Public Schools, which kept students out of classrooms for almost a whole year during the pandemic. Not only does DHS want to recruit and build a diverse workforce to meet the evolving threat landscape, but the state's share of federal Covid-19 relief dollars is, in part, intended to serve pandemic-impacted communities of low-to-moderate income households, households that experienced food insecurity, and K-12 students who lost in-person instruction for a significant amount of time.

3) Making research and tools available to the public. The ongoing pandemic has caused disruption, job loss, isolation, and suffering. NCITE is well-positioned to offer education, training, and prevention tools to build community resilience.

4) Violence prevention will need to include projects to build community resilience, which can begin with education and training offered by NCITE. This is one of many ways NCITE aims to prevent and respond to violence especially as pandemic-fueled suffering.
