LB 900 amends section 53-123.16, related to the operation of microdistilleries. Under LB 900, such operators would no longer be restricted to producing at a singular location, and could instead produce up to the maximum of 100,000 gallons between 5 different physical locations.

The Nebraska Liquor Control Commission estimates no fiscal impact to revenue or costs as a result of LB 900. There is no basis to disagree with this estimate.
