LB 843 amends the Election Act providing a listing of what shall be included in "political subdivision" and allowing the term "Signature" to include the symbol of a person.

Section 5 allows for persons with a disability who, by reason of that disability, are unable to write in their name or symbol to substitute a mark if their name is written by some other person or an impression made using a signature stamp.

Section 7 and 8 allow an election commissioner or county clerk to appoint an elector residing outside the county as a precinct inspector, district inspector, judge of elections, or clerk of election if the elector resides in a county which conducts all elections by mail.

The Secretary of State estimates no fiscal impact.
