LB 19 changes the dollar amount thresholds for criminal penalties for certain offenses, to redefine terms, to provide for applicability of changes, to eliminate obsolete provisions, to harmonize provisions and repeal the original sections.

Expenditures:

The Supreme Court states there could be minimal fiscal impact. If fewer individuals are convicted or convicted of lesser offenses pursuant to the bill, there could be fewer individuals incarcerated in county or state facilities, depending on the level of the offense, or subject to fines. Fines are paid for the benefit of the common schools.
