LB 156 changes the caseload ratio a public guardian and conservator can accept from twenty to twenty-two appointments.

Expenditures:

LB 156 increases the caseload for Associate Public Guardians (APG) from 20 to 22, in order to sustain the same level of care for wards APG would increase overtime for APGs and associated administrative staff. The Office of Public Guardian (OPG) shows that APGs spend around 2.5 hours per week per ward and administrative staff 1.5 hours. The estimated cost of the additional hours needed would be \$300,000 per fiscal year.

There is no basis to disagree with this estimate.
