This bill states legislative intent to appropriate an additional \$500,000 annually to the Foster Care Review Office (FCRO) to Program 317 Court Appointed Special Advocate (CASA) Aid. Currently, this program receives \$500,000, and this bill states legislative intent that a total of \$1 million be appropriated annually for this purpose.

Program 317 CASA Aid was created in Agency 70 in FY22 by LB 380. Prior to FY22, CASA aid was administered through the Judiciary. Administration costs associated with administering CASA aid in this program are absorbed by FCRO.

The agency indicates there is no fiscal impact.
