Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 609 states the intent to appropriate \$2,500,000 in general funds to the Department of Veteran Affairs for the purpose of awarding a grant to a not-for-profit organization to construct a memorial to honor the three hundred ninety-six Nebraska military personnel who were killed in action during the Vietnam War. The bill contains an emergency clause.

NOTE: The Department anticipates a need for additional funding in personal and operations to administer the grant in FY 2023-24 if the bill should be approved.

## FY 2024:

The Department estimates that the agency would require a .5 FTE for an Administrative Programs Officer I in FY 2024. This FTE would be hired upon the approval of the bill and provide personal services for the remaining of the fiscal year.

• Personnel costs- \$20,416, Benefits/Employer Taxes-\$6,931 and Operations-\$5,000 for a total cost of \$32,347.
