LB842 makes the following changes to housing law:

- Amends definitions under the Municipal Density and Missing Middle Housing Act and Nebraska Affordable Housing Act;
- Adds an allowable education course as an eligible activity under the Affordable Housing Trust Fund;
- Adds projects making reentry or transitional housing more accessible under the Affordable Housing Trust Fund;
- Under the Nebraska Housing Agency Act requires monthly rental costs including utilities to not exceed 30% of the tenant's annual income; and
- Amends definitions under the Nebraska Housing Agency Act.

The act declares an emergency. Amending definitions may change distribution of funds. No fiscal impact.
