Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 1220 proposes amendments to property law, particularly concerning personal representatives, small estate affidavits, payments and transfers to minors, and the roles of trustees and conservators.

Section 4, Section 30-2637, is amended to affirm the right of a protected person to hire an attorney for specific purposes, including challenging conservatorship terms or the conservator's actions.

Additionally, Section 6, Section 30-3816, outlines the procedure for establishing a trust's primary administration site when multiple trustees are involved, providing a resolution method for disagreements. The bill also specifies that only a trustee can register a trust and underlines that such registration is not mandatory for court jurisdiction over the trust.

Expenditures:

The Supreme Court would have a minimal fiscal impact from LB 1220.

The Department of Health and Human Services (DHHS) would have no fiscal impact.

The Department of Banking and Finance did not submit a fiscal note response for consideration. Upon review by the fiscal office, it appears that the proposed legislation would have no fiscal impact on the agency.
