Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 301 provides that "eligible aliens" will be eligible to become law enforcement certified if hired by a law enforcement agency. LB 301 defines an "eligible alien" as any alien who has been granted work authorization by the United States. Eligible aliens as defined by LB 301 would also be eligible to receive public benefits relating to employment as a law enforcement officer. This includes retirement benefits, deferred compensation under § 84-1504, scholarships or financial aid for education, and any other benefit relating to employment, including what would apply to their family members or dependents.

The Department of Administrative Services (DAS) does not identify fiscal impact to its agency, but does not comment on potential impacts to the state. Lancaster County and the Nebraska State Patrol claim no fiscal impact to their agencies. The Nebraska Association of County Officials does not foresee any additional costs or savings to counties.

There could be some fiscal impacts to the state, but that the exact amounts cannot be determined without knowing the number of new state employees that would be hired under passage of LB 301, or the exact benefits that would be applied for and claimed. For example, deferred compensation and retirement benefits would be tied to job codes, salary ranges or individual paycheck calculations for employees of the state. Tuition waivers could be applied to any eligible alien as defined by LB 301, not just state employees. Average annual tuition costs range from approximately \$4,000 to \$12,000 in Nebraska's public higher education institutions. As of this date, no state funding has been appropriated for tuition waivers under the First Responder Recruitment and Retention Act. Actual fiscal impact could be calculated for tuition or other benefits at some point in the future. It is foreseeable that impacted agencies could request supplemental funding for these benefits in the future.
