LB255 intends to appropriate \$1,000,000 in FY25-26 and \$1,000,000 in FY26-27 from the Opioid Treatment Infrastructure Cash Fund to the Supreme Court. The purpose of the funding is for use in problem solving courts to order medication-assisted treatment that involves the use of medication approved by the federal Food and Drug Administration, in combination with counseling and behavioral health therapies, for the treatment of substance use disorders. The department would work with the Supreme Court to provide access to the funding.
