LB 596 updates the requirements for the publication of legal notices within the state. The bill allows the publication of legal notices not only in traditional newspapers but also digitally, on websites or applications of digital news publications, provided that the digital news publication does not also have a print version.

The Supreme Court has stated that LB 596 will have a minimal fiscal impact and will not require any additional resources.
