Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 388 amends statues regarding the judicial nominating process by tightening residency and political party requirements, limiting commission service to 8 consecutive years, and streamlining electronic nominations for lawyer members. It mandates faster public hearings, immediate vacancy appointments, and automatic removal for disqualified members.

The Supreme Court states that there is a potential for a reduction in General Fund expenditures due to these changes, but any savings are expected to be minimal.
