LB 519 amends Nebraska's correctional services laws by requiring independent confirmatory testing of potential contraband drugs before disciplinary action is taken against inmates.

The Nebraska Department of Correctional Services estimates that the bill may lead to an increase in the number of confirmation tests requested, as well as the number of initial positive results that are ultimately overturned. While the exact impact remains indeterminable, any additional costs incurred for tests that return negative results would be absorbed within the agency's existing appropriation.
