Regulation of broadband Internet access service shall be vested with the Federal Communications Commission. No state agency, board, or commission or political subdivision shall enact, adopt, or enforce any law, rule, regulation, or ordinance that would impose any regulation barred under section 86-124 (1)(d). The provisions of this section shall not affect or modify any authority delegated to the Public Service Commission or any state agency, including, but not limited to, the Nebraska Broadband Office, to administer a federal or state broadband grant program under a federal or state statute, rule, or order.
