Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 672 relates to the Nebraska Political Accountability and Disclosure Act. The bill would limit contributions to a candidate committee to one thousand dollars during an election period. The stipulations would not apply to a candidate's own personal funds contributed to that candidate committee. The bill further requires that contributions which exceed the stated amount shall be returned and reported as prescribed.

The Nebraska Accountability & Disclosure Commission (NADC) estimates that the bill would require a modified online filing system to track and collect the potential refunds of the funds contributed that exceed the limits as defined in the bill. NADC anticipates a one-time cost of \$25,000 to complete these updates to the filing system. Additionally, NADC anticipates on-going expenses of \$1,500 to modify and reprint forms and instructional materials and to provide notification and education to candidates.
