Re: Overdue Regulations Report

Overview

Under the Nebraska Administrative Procedure Act (APA), if the Legislature passes a bill requiring an administrative agency to promulgate regulations, the agency must promulgate the regulation within two years of the bill going into effect. Agencies are required to report the status of these regulations to the Legislative Audit Office (Office) by July 1 each year. Additionally, if mandatory regulations are not promulgated within three years of a bill's effective date, the law requires the relevant legislative standing committee to hold a public hearing.

2025 Report

All required agencies except the Abstracters Board of Examiners submitted a report to the Office. Three agencies, the Department of Health and Human Services, the Commission for Postsecondary Education, and the Public Service Commission, reported regulations that may be overdue. Those reports are attached to this memo. As per Office practice, the reports were forwarded to counsels and chairpersons of the relevant standing committees.

2018	LB 993	Cash funds were transferred into the 911 Service System Fund to hire staff and consultants, and to obtain contractual services to implement Next Generation 911. The funds have been used by the agency for that purpose. The implementation phase of the Next Generation 911 system is still in progress.

2018	LB 993	As noted above, the regulations are currently in process of promulgation. Importantly, before the formal promulgation process on the regulation could take place, the drafted regulations had to be approved by the Committee. As provided in last year's report, the entire Committee had to be appointed or reappointed (as all previous terms ended at the same time), taking additional time to prepare and review the drafted regulations. This year, a working group of the Committee and the PSC's 911 department staff did review and approve the drafted regulations. As well, the 911 department staff made additional changes to the drafted regulations to reflect requirements contained in LB 362 (2025) and LB 1031 (2024), which had been passed during the drafting and Committee approval processes. LB 362, in particular, was brought by the Commission to eliminate inconsistencies and redundancies among several 911 statutes.

2023	276A	The program is expending the funds appropriated in LB276A to pay for the costs to develop the program, such as to develop coverage criteria, collect cost report information to develop Perspective Payment System rates, certify participating providers, and seek federal approval of the program. While the department does not have regulations promulgated, the program development work has been underway and is on schedule to be completed to adhere to the coverage of the Certified Community Behavioral Health Clinic (CCBHC) service on January 1, 2026, as required per statute.

6. For each bill, please explain why the regulation has not been promulgated.

Year Passed	Bill Number	Explanation
2023	276	The collaboration required by LB276 to build a new model with input from CCBHCs necessarily delayed promulgation of regulations to ensure the required alignment of payment systems and services were in place and appropriate for implementation of the CCBHC program to meet the intentions of LB276. In addition to adding the required

	regulatory requirements, comprehensive changes to all impacted chapters were made to ensure the chapters are the least restrictive while still meeting the statutory requirements. As the regulations had neared drafting completion, the comprehensive changes referenced required substantial additional edits to ensure compliance with regulatory strategy and the intent of LB276.
