BILL SUMMARIES: 2022 BILLS ENACTED

LB 531 (McKinney) Create and change grant and economic and community development programs, change municipal governance and regulation provisions and state building code provisions, authorize transfer of investment interest on certain funds and Cash Reserve Fund transfers, and authorize development of the Mayhew Cabin historical site and a Chief Standing Bear museum and visitor center

LB 531 overall helps direct funding for North Omaha and South Omaha.

The bill amends sections of Chapter 16, 17, 18, 19, 58, 71, and 72 to complete the legislation began in 2022 as LB 1024, otherwise known as the North Omaha and South Omaha Recovery plan.

Projects in 2022 were identified in the legislation to move forward immediately through an RFP process implemented by the Department of Economic Development, including internships, IHUB, business park planning grant, and tourism.

For the remaining \$225 million, the state legislature instructed the Economic Recovery Committee to contract with an engineering firm to put together a master plan. Olsson was selected to collect the submissions, and made recommendations to approve 35 of the plans for funding. LB 531 directs these funds.

The current legislation has switched funding from ARPA to general funds to allow more flexibility and more time for projects to get completed.

The committee amendment, AM 1880, made several additional clean-up changes to the underlying bill and incorporated the provisions of eight other Urban Affairs bills into the bill: LB 33, LB 45, LB 532, LB 629, LB 98, LB 170, LB 223, and LB 342. AM 1880 also added the Emergency Clause for the entire bill, along with a severability clause.

On Select File, LB 531 was further amended with AM 1835 (which added LB 474), AM 1757 (which added LB 462), AM 1789 (which added LB 329), AM 1771 (?), and AM 1838 (which added LB 346.)

BILL SUMMARIES: 2023 BILLS ON GENERAL FILE

LB 6 (Blood) Prohibit conditional use permits and zoning exceptions for delinquent property taxpayers

LB 6 prohibits any person from applying for a conditional use permit if they are more than 180 days delinquent in the payment of real property taxes. This requirement may be waived if the delinquent taxes owed are in dispute, on appeal, or the result of an administrative error.

LB 21 (Wayne) Change provisions relating to the city council of a city of the metropolitan class

LB 21 changes the number of city council members in each city of the metropolitan class from seven members to nine members starting in the May 2025 general city election.

LB 33 (Jacobson) Change provisions relating to the powers of mayors in certain cities and eliminate obsolete 2020 redistricting provisions

LB 33 allows the mayor of a first or second class city to vote on any matter which requires a majority vote of the city council. This may occur if the mayor's vote is required due to the council being equally divided or a majority cannot be reached due to absence. LB33 does not allow the mayor to vote when a super-majority vote of the council is required.

LB 33 was amended into LB 531.

LB 45 (Dorn) Create the Revitalize Rural Nebraska Grant Program

LB 45 would create the Revitalize Rural Nebraska Grant Fund for cities of the first class, second class, or village. This grant would provide for a dilapidated commercial property demolition, and would be run by the Department of Environment and Energy. There shall be no limit on the amount that can be awarded to each application within the available funding.

When amended into LB 531, LB 45 was changed to have a one-time total grant of \$1 million dollars.

LB 45 was amended into LB 531.

LB 98 (Jacobson) Change provisions of the Community Development Law relating to substandard and blighted declarations and expedited reviews of redevelopment plans

LB 98 concerns Micro-TIF, which concerns redevelopment plans receiving an expedited review under Neb. Rev. Stat. §18-2155. LB 98 would add an optional resolution before declaring an area to be substandard and blighted, allow limits on the number of expedited reviews of redevelopment plans, and permit redevelopment plans to be denied

LB 98 was amended into LB 531.

LB 170 (McKinney) Redefine blighted area under the Nebraska Investment Finance Authority Act

LB 170 matches the definition of "blighted area" under the Nebraska Investment Finance Authority Act with the definition under the Community Development Law (18-2103.)

LB 170 was amended into LB 531.

LB 171 (McKinney) Name the Metropolitan Utilities District Act and transfer and change provisions relating to metropolitan utilities districts

LB 171 is a Metropolitan Utilities District (MUD) clean-up bill. Sections 2 through 58 of the bill have been named the Metropolitan Utilities District Act. The bill also makes a change to the MUD board of directors, providing that the board shall be chosen at the

statewide primary and general elections within the voter's respective election subdivision.

LB 172 (Bostar) Adopt updated electrical standards

LB 172 updates the National Electrical Code from the 2017 edition to the 2023 edition.

LB 223 (McKinney) Provide and change reporting requirements under the Municipal Density and Missing Middle Housing Act

LB 223 concerns the Municipal Density and Missing Middle Housing Act. It requires each city that adopts an affordable housing action plan electronically submit their plan to the Urban Affairs Committee.

The bill also allows an option in the report to either (1) show efforts to affordable housing action plans or (2) efforts to implement an affordable housing action plan after such a plan is adopted.

LB 223 was amended into LB 531.

LB 224 (McKinney) Adopt the Aid to Municipalities Act

LB 224 would create the Aid to Municipalities Act. This Act would allow for grants that would pay for infrastructure projects within municipalities of any class. These grants may only be used to pay for construction or bonds. Once instituted, the Legislature would appropriate \$15 million each fiscal year towards the Act.

LB 246 (McKinney) Change provisions relating to sanitary and improvement districts

LB 246 harmonizes SID statutes by adding references to extraterritorial zoning jurisdictions. LB 246 also cleans up long paragraphs in the statutes by adding in numerical sectioning.

LB 329 (Raybould) Prohibit the application of the state building code in a manner that would prohibit or limit the use of certain refrigerant

LB329 would align state law with the federal American Innovation and Manufacturing (AIM) Act by permitting the use of refrigerants and equipment designated as acceptable in the federal legislation.

LB 329 was amended into LB 531.

LB 342 (Hardin) Change provisions relating to home inspectors

LB 342 would remove the requirement that home inspectors should register with the Secretary of State every even-numbered year. The bill would also allow home inspectors to renew registration within 45 days of expiration, and have this registration be valid for 2 years.

The committee amendment, AM 75, is a white-copy amendment that replaces "business" days with "calendar" days.

LB 342 was amended into LB 531.

LB 346 (Brandt) Redefine qualifying business under the Local Option Municipal Economic Development Act

LB 346 would allow qualifying businesses in cities with a population of 5,000 or less to be qualified even if they derive its principal source of income from activities other than those set out in the statute. This changes the number from 2,500.

Under the current language, this bill would only apply to cities of the second class: With the language of "city" and the prescribed population cap of 5,000, the only type of municipality that fits this definition are cities of the second class.

LB 346 was amended into LB 531.

LB 462 (Conrad) Redefine a term under the Middle Income Workforce Housing Investment Act

LB 462 would update the qualifications for owner-occupied housing units under the Middle Income Workforce Housing Investment Act.

Currently, construction of new owner-occupied housing for the Middle Income Workforce Housing Investment Act has to meet an after-construction appraised value of at least \$125,000 and not more than \$275,000. Under LB 462, this would change to units that, under total construction costs, cost no more than \$330,000.

Also under LB 462, the housing unit after-construction appraised value shall be updated annually by the department based upon the most recent increase or decrease in the Producer Price Index.

LB 462 was amended into LB 531.

LB 532 (McKinney) Change provisions of the Community Development Law

LB 532 would change provisions of the Community Development Law. These provisions include timely limits of how short an area may be designated as "extremely blighted," extending the deadline for housing studies in cities other than those in the metropolitan class, and placing limits on the creation of new redevelopment plans in areas still designated as blighted.

The committee amendment, AM 1560, is a white-copy amendment that adjusts the restrictions on tracts from creating new redevelopment plans.

LB 532 was amended into LB 531.

LB 533 (McKinney) Change plumbing board membership for cities of the primary class and provide for licensure requirements for plumbers in certain cities and villages

LB 533 would change plumbing board memberships for cities of the primary class by increasing the number of members on the plumbing boards from five to seven members. LB 533 also provides for licensure requirements for plumbers in certain cities and villages.

LB 629 (McKinney) Change provisions of the Middle Income Workforce Housing Investment Act and the Economic Recovery Act

LB 629 changes provisions of the Middle Income Workforce Housing Investment Act and the Economic Recovery Act. The overall bill incentivizes affordable housing projects by establishing a workforce housing investment grant program for urban areas of the state and requiring affordable housing action plans. The Qualified Census Tract (QCT) Affordable Housing Program, also created by LB 1024, is available for the purposes of preparing land parcels for affordable housing or conducting other eligible affordable housing interventions within qualified census tracts located in a city of the metropolitan class and a city of the primary class.

LB 629 was amended into LB 531.

LB 707 (Dungan) Provide for grants to cities of the primary class from the Affordable Housing Trust Fund

LB 707 would create the Transforming Cities of the Primary Class Program, which would be used for the purpose of constructing housing to address affordable housing needs in a city of the primary class. The Department of Economic Development would award up to ten million dollars of available grant money for such purposes.

BILL SUMMARIES: 2023 BILLS HELD IN COMMITTEE

LB 164 (McKinney) Adopt updates to building and energy codes

LB 164 updates the International Building Code (energy efficiency provisions), International Residential Code (energy efficiency provisions), and International Energy Conservation Code from the 2018 editions to the 2021 editions.

LB 274 (Holdcroft) Provide for persons with disabled veterans license plates to park in handicapped parking spaces

LB 274 allows for persons with disabled veterans license plates to park in handicapped parking spaces. The bill would amend existing law to change provisions related to handicapped parking, allow disabled veterans to park in handicapped parking spaces, and repeal the original sections of the existing law.

LB 389 (Linehan) Restrict the use of tax-increment financing

LB 389 would amend existing Nebraska law to prevent a parcel of property from having its taxes divided as part of a redevelopment project. Properties would not be divided if they had been previously divided in the last 50 years in accordance with the existing law.

LB 424 (DeBoer) Create the Department of Housing and Urban Development

LB 424 would create the Department of Housing and Urban Development and grant it jurisdiction over matters currently overseen by other departments. Additionally, LB 424 amends existing statutes to reflect these changes and outright repeals the statute which creates the housing advisory committee.

LB 481 (Raybould) Adopt the Housing Incentive District Act

LB 481 would adopt the Housing Incentive District Act, which would encourage the development and renovation of housing in cities and counties by authorizing these entities to assist directly in the financing of public improvements that will support housing in areas that experience a shortage of housing.

LB 481 would be accomplished through the following steps:

- Conducting a housing needs analysis to determine the needs within the proposed district.
- The adoption of the following: a resolution containing a legal description of the proposed district, a map depicting the existing parcels of real estate in the proposed district, and statements of particular findings.
- A plan for the development of housing and public facilities in the proposed district
- A public hearing

If approved, a grant is then developed for cities or counties to carry out housing development activities. The city or county will provide matching funds in an amount equal to either (1) at least 10% if the funds are to be used for construction, or (2) at least 50% if the funds are to be used for a purpose other than construction of infrastructure.

The Nebraska Investment Finance Authority may award up to \$2 million of grants each year. These funds shall be appropriated from the Legislature.

LB 530 (McKinney) Change provisions of the Nebraska Housing Agency Act

LB 530 amends the Nebraska Housing Agency Act to:

(1) have 2 metropolitan city housing agency commissioners be elected by the people of the housing agency every four years,

(2) prohibit commissioners from also being officers or employees of a metropolitan city,

(3) specify the election process for a metropolitan city housing agency commissioner, and

(4) provide how a metropolitan city housing agency commissioner may be removed from office.

LB 546 (Conrad) Provide requirements for bed and breakfast establishments regarding food, beverages, and fire safety

LB 546 addresses consumer safety and business owner responsibilities for Nebraska bed and breakfast establishments by redefining bed and breakfasts, applying updated fire code regulations to them, and explicitly outlining cleanliness requirements for food, handlers, and environment.

In Section 4(1)(a), the bill establishes a meaning of Bed and Breakfast. The definition of Bed and Breakfast is already defined in the 2012 National Fire Protection Association (NFPA) 101 Life Safety Code (LSC) in Chapter 26 Lodging and Rooming Houses.

LB 546 would promote a fire code that aligns with the National Fire Protection Association as undertaken by the State Fire Marshal. Overall, this would decrease the sprinkler system requirements in the state of Nebraska.

Additionally, not subjecting bed and breakfasts to provisions under the Pure Food Act means no health department inspection.

LB 746 (Cavanaugh, M.) Restrict the use of tax-increment financing

LB 746 would require an election in order to allow for the division of taxes if the redevelopment project in question is estimated to exceed \$20 million in ad valorem taxes.

BILL SUMMARIES: 2023 BILLS INDEFINETLY POSTPONED

LB 691 (Linehan) Require the city or owner of a fixed rail or streetcar system to pay projectrelated costs for utilities

LB 691 would require the city or its streetcar authority to pay its fixed rail or streetcar system's natural gas and water utilities costs.

LB 693 (Linehan) Require an authority under the Community Development Law to pay project-related costs for utility work for a fixed rail or streetcar system

LB 693 would create the ability for an authority to pay for the project-related costs for natural gas and water utilities when it comes to a redevelopment project within a city of the metropolitan class for any project that includes a fixed rail or streetcar system.
