PRESIDENT: The motion carries and LB 41 is advanced to E & R Initial. The next bill is LB 18.

CLERK: Read title. The bill was read on January 8, referred to the Government, Military and Veterans Affairs Committee. It was advanced to General File. There are committee amendments pending by the Government Committee, Mr. President.

PRESIDENT: Senator Vickers, do you want to handle the amendment? It looks like the chair and the vice chair are absent so will you take the amendments too? The Chair recognizes Senator Vickers.

SENATOR VICKERS: Yes, I will, Mr. President. Thank you. The committee amendments on LB 18 were added to LB 18 by the committee at my request and I will be happy to handle their committee amendment. The amendment is simply, because of a mistake on my part when the bill was drafted, on page 2, line 8, before the word "Unicameral", insert "nonpartisan Unicameral" since that is what this body is by Constitution and it was very important to Senator George W. Norris that that word was in there. Nonpartisan was to Senator Norris almost as important part of establishing the Unicameral as the establishing of the Unicameral itself. I thought it was quite an oversight on my part that that word was not included and I would urge the body's adoption of the committee amendment.

PRESIDENT: The Chair recognizes Senator Wagner, speaking on the amendment. Senator Wagner.

SENATOR WAGNER: Mr. Speaker, I really wanted to speak to the bill but I do support the amendment.

PRESIDENT: All right, any further discussion then on the committee amendment? If not, all those in favor of the committee amendment to LB 18 vote aye, opposed nay. Have you all voted on the amendment? Record the vote.

CLERK: 26 ayes, 0 nays on adoption of the committee amendment, Mr. President.

PRESIDENT: The motion carries. The committee amendment is adopted. Senator Vickers, do you have any further discussion on the bill itself? Senator Vickers, do you have any further discussion on the bill now?

SENATOR VICKERS: Yes, Mr. President, I do think that it is important that this body, representing the people of the State of Nebraska, does pass this legislation to establish a Senator George W. Norris Day. Of course, I am double proud of Senator

Norris since Senator Norris was from my legislative area. Unfortunately I am not old enough to have remembered Senator Norris but I think everybody in the nation will remember and reap the benefits of Senator Norris' long public service career. Senator Norris served in the Congress of the United States for four years as a Representative of the State of Nebraska and as so often happens with statesmen, and I considered Senator Norris as a real statesman, the benefits of their service sometimes is not available to the public at the time of their service as much as it is in later years as history unfolds. Senator Norris was the leading or led the fight to establish the TVA, the Tennessee Valley Authority, and I might add also led the fight to get the funding for the Tri-County system, Lake McConaughy and the benefits that Nebraska has derived from that is untold. He was able to see back in the late '20s the need for conservation of natural resources and the need for the use of those resources to generate power because of the tremendous amount of energy needed in the United States. He, of course, led the fight for rural electrification and I think a lesson for those of us in this body can be learned by his dedication and his ability to persevere under extreme conditions in that fight. He introduced legislation, I believe it was for thirteen years, before finally getting it passed that created the Rural Electrification Administration. Those of us from Nebraska and particularly those of us from rural Nebraska owe Senator Norris a great debt of gratitude for bringing electricity to our farms and as I indicated earlier I am not old enough to remember Senator Norris but I am old enough to remember when electricity came to our place and we were able to blow out those kerosene lamps for the last time. I think it is important that this body, this Unicameral body, created itself in large part by Senator Norris. He led the fight back in 1934 through a referendum of the people to get the State of Nebraska to embark on what was called then, the Great Experiment, what many people ridiculed that wouldn't last. I personally think that we are all in here as living examples that Senator Norris was right and that it was the right thing to do. Again, I would just simply urge this body to adopt LB 18 so that the people of the State of Nebraska, particularly the young people of the State of Nebraska will realize there was a great Nebraskan that they can look up to and pattern their lives after.

PRESIDENT: The Chair recognizes Senator Wagner.

SENATOR WAGNER: Mr. Speaker and members, I think it is very good of Senator Vickers to bring this bill before us and he also, I do want to thank him for allowing me to co-sponsor the bill with him. I am a native of McCook, Nebraska, where Senator Norris is from. I grew up there and not too far from

our school he has his residence. That residence now is a state historical site. They also have acquired Senator Norris' old car. It must be about a 1937 Oldsmobile-Buick. Many of us in this room here, Senator Vickers, served on Public Power Boards, Senator Sieck, Senator Lamb. I worked for a consulting engineer. I laid out a number of power lines and substations throughout the state but these basically were in relation to public power district, PEAs, co-ops. Many times for the first time in people's lives they received power and you don't really see an expression like this much anymore but for the first time somebody receives power they get rid of, like Senator Vickers talked about, they get rid of the kerosene lamps and they really brighten things up. It is really amazing how things have changed from then to now because basically most of the first homes about the only thing they had in there was a light bulb hanging from the ceiling plus a toaster. Today you go into the rural farm homes and you can begin to see the real results of the rural electrification of the rural areas. Today you've got TV, you've got almost any unlimited number of utilities, utensils, utilities and so forth that the farm group uses any more. I, therefore, very much support this resolution and I thank Senator Vickers again for bringing this forth. I really support the bill.

PRESIDENT: The Chair recognizes Senator Schmit.

SENATOR SCHMIT: I would just like to add my support for the bill. I commend Senator Vickers and Senator Norris (sic) for bringing it to our attention. I would like to point out that I am a little older than Senator Vickers and I do remember Senator Norris. He was somewhat of a controversial character as we all know back in his day and many times was a politician who stood alone and was not afraid to champion causes which at that time were considered somewhat far out. I would like to invite some of you if you ever have the opportunity to visit the Tennessee Valley Authority and view the vast improvements down there in that area and visit with the people to recognize what a change that area went through as a result of Senator Norris' efforts. I would like to hope that here in Nebraska we would not have to look a thousand miles away to find someone to bring the kind of leadership to Nebraska that would enhance and conserve those resources that we have here today for the benefit of our own citizens and I know that many of the causes that Senator Norris championed many years ago would be even more controversial today but if it had not been for his leadership, his strength and his courage, as Senator Vickers has said, there wouldn't be any PEA. I wonder sometimes just how successful that kind of a project would be today if you were to go to Congress and talk about cost benefit ratios for building power lines out to the ranches

and farms of Nebraska today I am sure he would be laughed out of the place but Senator Norris did it and I would suggest that many of the investments that we are being called upon to make in the interest of our people will some day be recognized as wise investments and so I think we should remember Senator Norris. We should commend his memory to the people of the State of Nebraska and remember that even his career ended in defeat at the hands of another very fine individual but that did not in anyway or should not in any way diminish the respect we have for a very fine political career that did a lot of good for the people, not only in his own native state but of all of the people of the United States.

PRESIDENT: The Chair recognizes Senator Nichol.

SENATOR NICHOL: Mr. Chairman, members of the Legislature, I, too, lend my support to this. I assume when you close, Senator Vickers, you will establish that this is not a legal holiday which I know is not intended in the bill. Thank you.

PRESIDENT: The Chair recognizes Senator Sieck.

SENATOR SIECK: Yes, Mr. Chairman, members of the body, I also support this amendment and I am a little older than Senator Vickers because I can still recall seeing Senator Norris when he was speaking to a body and I just really thought he was a wonderful man and I can also recall when I campaigned for him when he was running for an Independent in the Senate of the United States and ran into a lot of opposition from those good Republicans but he did win and I was just a young man. I also can thank, we can thank Senator Norris for what rural America is today. If it wouldn't have been for him we wouldn't be where we are today in rural American and we can really be proud of it and I heartily ask you to support this bill. Thank you.

SPEAKER MARVEL PRESIDING

SPEAKER MARVEL: Senator Rumery.

SENATOR RUMERY: Mr. President and members of the Legislature, I will not spend any time explaining to you that I had seen Senator Norris but for obvious reasons you already know that. But the State of Tennessee has honored Senator Norris many times. They named a power plant and a dam in his honor and I have relatives who went down there and when they would meet a native Tennessean why they would say, where are you people from and they said, well we came from Nebraska and they would light up right away and say, oh, Senator Norris'

state. I think it is high time that we in his native state do try to recognize him in a positive way and I want to thank Senator Vickers for bringing this to us.

SPEAKER MARVEL: Senator Vard Johnson.

SENATOR V. JOHNSON: Mr. Speaker, members of the body, I, too, am very pleased that Senator Vickers and Senator Wagner would bring to us this bill and recognize Senator George W. Norris. One of the things that is important to me about the recognition of this man is that it reflects again that from this rock ribbed part of our nation can come a politician, a statesman who is a known liberal because George Norris certainly was that. When you stop to realize that this man was only one of six in the United States Congress that voted against our entry into the first world war, you have to appreciate what a maverick he surely must have been but the important thing about Senator Norris was that Senator Norris stood for the people just as William Jennings Bryan, the great commoner from Nebraska, stood for the people. For year in and year out we come to believe that our prevailing ethic in this state is a very conservative ethic and yet when we recognize we are the only state in the Union with all public power, when we recognize that we have public irrigation districts, when we recognize that we have sent to Congress, men who fought hard for the rights of the people, we have to realize that out of our own state, out of our own heritage, out of our own background comes a genuine belief in the uses of the government to meet the needs of all in society and in this day following an address by our President, that we would have to continue to cut back and erode the rights of the poor and the needy and the desperate, I think it is only fitting that we honor that fighting liberal, George W. Norris.

SPEAKER MARVEL: Senator Vickers, do you want to advance the bill?

SENATOR VICKERS: Yes, Mr. President, I would like to make a comment though on closing that Senator Nichol mentioned. It is not my intention to create a state holiday. This is just simply my intention to create a day that we can honor Senator Norris by flying the flags and appropriate exercises in schools and so forth, but I would urge the body's advancement of LB 18.

SPEAKER MARVEL: All those in favor of advancing the bill vote aye, opposed vote no. Have you all voted? Record the vote.

CLERK: 35 ayes, 2 nays, Mr. President, on the motion to advance the bill.

This is a technical amendment needed because the rest of the bill refers to public bodies not districts. So it for language uniformity. The other part of the amendment would insert at the bill a sentence that makes it the Board of Educational Lands and Funds duty to file a copy of the easement in the office of the Register of Deeds in the county where the easement is located. The statutes currently place this requirement on the board when they sell property, so this amendment is to keep the board's duties uniform. I think this is self-explanatory and it does...is necessary to make the language read correctly, and so I move for the adoption of the committee amendments.
