MONSIGNOR KEENAN: Prayer offered.

SPEAKER MARVEL: Roll call. Will you please record your presence. Have you all recorded your presence? Record the vote.

CLERK: There is a quorum present, Mr. President.

SPEAKER MARVEL: Do you have some items to read into the record?

SPEAKER MARVEL: Okay, we will go to item #4, introduction of new bills.

CLERK: Mr. President, Senator Nichol moves to suspend Rule 5, Section 5 so as to permit the introduction of Request 889 by himself.

SPEAKER MARVEL: Senator Nichol.

SPEAKER MARVEL: The motion is carried. The bill is advanced. The next bill is LB 195.

CLERK: Mr. President, LB 195 was introduced by Senator Warner. (Read title.) The bill was read on January 15, referred to the Banking Committee for public hearing. It was advanced to General File. There are committee amendments pending, Mr. President.

SPEAKER MARVEL: Senator DeCamp.

SENATOR DeCAMP: Mr. President, the committee amendments will only make sense in light of a little bit of an explanation of the bill, and with Senator Warner's permission I would give just a slight explanation of the bill. Is that okay, Senator Warner? First of all, let me alert you. This is a major bill. I think one of the important bills. If we do this we will be the only state in the United States to pioneer this particular concept. We are the first of the fifty states. And it would change the way insurance companies handle their reserves, their money. And we have done some studying and work with the insurance industry in Nebraska, and we think it would be beneficial in the state in terms of building stronger insurance companies and in possibly bringing new insurance companies into the state, and in recognizing strength rather than mere size of an insurance company. Under present law, insurance companies are very limited in what they can invest their money in. We have a number of insurance companies in Nebraska that have developed very, very strong reserves, the very thing Senator Higgins was talking about yesterday. So instead of taking this strength and simply dissipating it in the form of dividends or being limited in the amount of earnings they can make and get on it, we would say, if you have reached a certain level, and I think it is in the bill maybe 2 to 1 or 2.5 to 1, if you have reached that level, then we are going to say you can invest in other things. You can put money in Nebraska banks, for example, and get high interest. You would have a wide range of options. As I say, this would be the first state in the United States to attempt such a thing. The Banking, Commerce and Insurance Committee has studied the concept and worked with some of the local people here in Nebraska for about 18 months now, and we have concluded that this is a good concept. Senator Warner graciously has sponsored the bill. The amendment then with this new concept simply says, however, if a new insurance simply comes in and is starting out, they would immediately have obviously the higher ratio, so you don't want to give them these

same rights or you want to have at least enough control to make sure it's not abused, so the amendment merely ensures that the Insurance Department would have tight control over any new insurance companies starting up to make sure that this new system is not abused. I urge you to adopt the committee amendments, and then Senator Warner can develop the rest of the bill further.

SPEAKER MARVEL: The motion is the adoption of the committee amendments to LB 195. Senator Pirsch.

SENATOR PIRSCH: Thank you, Mr. Speaker. A question for Senator DeCamp.

SENATOR DeCAMP: I'll try.

SENATOR PIRSCH: In the committee amendments it says strike original sections 7 and 8. Oh, excuse me, I'm sorry. I was still back on the other bill, excuse me.

SENATOR DeCAMP: That's okay.

SPEAKER MARVEL: All those in favor of the adoption of the committee amendments vote aye, opposed vote no. Have you all voted? Record.

CLERK: 27 ayes, 0 nays, Mr. President, on the motion to adopt the committee amendments.

SPEAKER MARVEL: The motion is carried. The committee amendments are adopted. Senator Warner.

SENATOR WARNER: Mr. President and members of the Legislature, I move that LB 195 be advanced to E & R Initial. Senator DeCamp has really briefly explained the bill and in essence of exactly what it does permit, the same restrictions that apply generally by law now to the kinds of investments that an insurance company can do the same reliable...rather the liability that the directors would have under existing law continue here. What it does encourage and permit is an expanded investment return actually strengthening the strength of the company back of the policyholders, and to that extent I think it is very beneficial. The alternative that they have, as Senator DeCamp pointed out, is to pay out the portion of those reserves in the form of dividends to either stockholders or policy holders, and the effect of that, of course, is removing the strength of the investment back of each policy. So I think that is an excellent proposal that will be to the benefit of both the policyholders

as well as the company itself, and as indicated the rule of thumb in the past on the quality of investment has been a quantitative type of thing of a minimum of \$1 of capital and surplus for every \$2 of annual premiums. You will find some companies less than that, but you have to meet at least that criteria before it would come into play and with that kind of strength back of the company in any event all we are doing is strengthen it even further and I would move that the bill be advanced. I can answer questions in depth if anyone wishes.

SPEAKER MARVEL: The motion is the advancement of 195 to E & R for Review. All those in favor vote aye, opposed vote no. Record.

CLERK: 25 ayes, 0 nays on the motion to advance the bill, Mr. President.

SPEAKER MARVEL: The motion is carried. The bill is advanced to E & R for Review. Underneath the south balcony it is my privilege to introduce a guest of Senator Koch, Mr. Ira Blalock who is a member of the Oregon Parole Board. Will you please stand so we may recognize you? Yes, sir. Welcome. In the north balcony from Senator Chronister's District guests from the Zion Lutheran Church at Leigh, Nebraska, nine members. The teacher, Gerald Kurka. That's in the north balcony. Will you raise your hand so we may see where you are? Welcome. Next, LB 272.

SENATOR DeCAMP: Mr. President, members of the Legislature, you have all heard of a limited partnership. The limited partnership laws were basically adopted back in about 1916. This year what we are doing with this is essentially rewriting the entire limited partnership law in accord with what has been developed, the old story, national models, modern experience, modern business practices, so on and so forth. The committee amendments make some technical changes. Those specific technical changes are, a \$10 fee for all filings, and that existing
