SPEAKER MARVEL: We now proceed to item #6, General File, and the first bill is LB 20.

CLERK: Mr. President, LB 20 was offered by Senator Howard Lamb of the 43rd District. (Read title). The bill was first read on January 8 of this year. It was referred to the Business and Labor Committee for public hearing. The bill was advanced to General File. I do have amendments pending by the Business and Labor Committee, Mr. President.

SPEAKER MARVEL: Senator Maresh.

SENATOR MARESH: Mr. Speaker and members of the Legislature, this amendment is two part. The first part deletes the December 1st deadline and just refers to when the court receives this notice. The second part is just a grammatical error in the bill and it changes from "such" to "which". I move that the committee amendments be adopted.

SPEAKER MARVEL: The motion before the House is the adoption of the committee amendments to LB 20. All those in favor of the motion vote aye, opposed no. Record.

CLERK: 27 ayes, 0 nays on adoption of the committee amendments, Mr. President.

SPEAKER MARVEL: The motion is carried and the amendments are adopted. Senator Lamb, do you want to explain your bill?

SENATOR LAMB: Mr. President and members of the Legislature, the purpose of this bill is to allow officers of a newly formed corporation to waive coverage of Workmen's Comp immediately after formation of the corporation. Currently the corporations must wait until December to waive this coverage. This bill also allows the waiver to continue in effect until terminated rather than terminating automatically after one year unless renewed. As you will probably remember, I believe it was a couple of years ago, we passed a bill which allowed corporate officers, certain corporate officers to waive this Workmen's Comp coverage. However, in the case of newly formed corporations there was a problem because

we did not specify that they could waive coverage from day one. So they had to wait until the following December to waive that coverage. So this was sort of an awkward thing in that they needed to be...under the law they had to be covered for a few months until December rolled around and that was the only time they could waive the coverage. This is merely a bill which would correct that obvious error.

SPEAKER MARVEL: Senator Maresh.

CLERK: Mr. President, Senator Maresh moves to amend the bill. (Read the Maresh amendment as found on page 426 of the Legislative Journal.)

SENATOR MARESH: Mr. Speaker, Judge Novicoff offered this amendment. What it does, it treats the newly formed corporations the same as the old corporations and so this would, in fact, be the bill now because Senator Lamb is trying to incorporate language that would apply to new corporations by treating...we adopted the committee amendments which did away with the deadline and states that whenever the court receives its notice it shall be effective. So what we are doing now is just applying the same language to the newly formed corporations. I move that the amendment be adopted.

SPEAKER MARVEL: Senator Lamb, do you want to talk to the amendment?

SENATOR LAMB: Only to say that this amendment came to me just a few minutes ago. I have had counsel look at it and I see no problems with it and I support the amendment.

SENATOR CLARK PRESIDING

SENATOR CLARK: Senator Cullan, do you want to talk on the amendment?

SENATOR CULLAN: Yes, Mr. President, I wonder if Senator Lamb might yield to a question about the amendment and I guess about the bill because I...Senator Lamb, I have to profess that I don't understand from your explanation exactly what the bill does and so it is hard for me to understand what the amendment does. When you talk about waiving Workmen's Compensation requirements, what then is the effect of that on the corporation and upon an individual who may be injured? Does he retain a right to sue outside of the Workmen's Compensation statutes, or perhaps you could give me some clarification in that area.

SENATOR LAMB: Senator Cullan, this body passed a bill, I believe it was two years ago, which allowed officers to opt out of Workmen's Comp, officers of a corporation. This does not change that part of it, except it facilitates the officers of a newly formed corporation to opt out of Workmen's Comp. Under the current law, they can only opt out during the month of December. So if you...for instance, if you formed a corporation in July, then under the law the officers would have to be covered by Workmen's Comp from that July until December because December was the only month when they could opt out of the program. So that really does not make that much sense. There is not much reason to force those corporate officers to be covered since they can opt out the following December. So the intent and thrust of this bill is merely to allow those corporate officers to opt out from day one and never be covered. And Senator Maresh's amendment which was suggested by Judge Novicoff is merely... well, it is language which eliminates some of the language that is duplicative in the bill and it doesn't really change that at all. It doesn't change the intent or what the bill does.

SENATOR CULLAN: Thank you, Senator Lamb, I appreciate very much your explanation of the bill. Since it doesn't affect the rights of an individual who would be an employee of the corporation, I certainly see no problem with it and I appreciate your taking the time and courtesy to explain it again for those of us who are a little slow today. Thank you.

SENATOR CLARK: Is there any further discussion on the Maresh amendment? If not, the motion is to adopt the Maresh amendment. All those in favor vote aye. All those opposed vote nay.

CLERK: Senator Clark voting aye.

SENATOR CLARK: Have you all voted? Record the vote.

CLERK: 29 ayes, 0 nays on adoption of Senator Maresh's amendment, Mr. President.

SENATOR CLARK: The motion passed. The amendment is adopted. Senator Lamb, what do you wish to do with the bill?

SENATOR LAMB: Mr. Chairman, I move that the bill be advanced.

SENATOR CULLAN: Mr. President and members of the Legislature, the Public Health and Welfare Committee adopted two major committee amendments to LB 69 and one amendment which I believe is technical in nature, and I would ask that you adopt all three as a package unless someone has an objection to that procedurally. The committee amendments change the age from under "four" years of age to under "three" years of age. As far as the requirement is concerned that an individual who drives a motor vehicle ensure that these individuals be properly strapped in or in a proper safety device in an automobile, it lowers the age requirement so that only individuals who are infants up to the age of...through the age of two would be included under the provisions of LB 69. The second change is to exempt public transportation vehicles. This would mean buses, taxis and any other means of public transportation from the requirements of the safety devices which are proposed in this particular bill. The third change is simply a change and is providing for a definition of motor vehicle and I am not sure what that definition is right now. It just refers to another section of state law. I can find that out if you want me to, but there was not a definition of motor vehicle referred to in LB 69. It is because there
