PRESIDENT: We are ready then for agenda item #5, introduction of new bills. Mr. Clerk, you may proceed with the reading of the new bills to be introduced today.

CLERK: Read title to LR 229-233 as found on pages 198-200 of the Legislative Journal. Mr. President, in conjunction with that bill we have a communication from the Governor advising the Legislature as to the intent of the bill and the supplemental appropriations required by various state programs. That will be inserted in the Legislative Journal. (See pages 203-204.)

Read title to LR 233-246 as found on pages 200-203 of the Legislative Journal.

Mr. President, your committee on Public Works gives notice of hearing for January 30 and February 6 and that is signed by Senator Kremer as chairman.

Mr. President, LB 40 was a bill introduced by Senators Koch, DeCamp and Goodrich. (Read title.) The bill was first read on January 8, referred to the Revenue Committee. The bill was advanced to General File. There are committee amendments pending by the Revenue Committee, Mr. President.

SPEAKER MARVEL PRESIDING

SPEAKER MARVEL: Senator Carsten.

SENATOR CARSTEN: Mr. President and members of the Legislature, I move for the adoption of the committee amendments. The committee amendments to LB 40 would require that the tax could not be continued, the Omaha city half-cent sales tax could not be continued after December 31, 1981 unless the majority of those voting in an election approved of the extension. I think the philosophy of the committee after we heard this bill realizing full well that the people of the City of Omaha did vote to accept the half-cent sales tax for a specific period of time, now this bill as it was presented is a permanent tax that would be put on. The committee felt that it was improper, I believe I am speaking for the committee, for this Legislature to impose upon the people of the City of Omaha a permanent half-cent sales tax without their consent or rejection and it was in that light that this amendment

CLERK: Senator Vickers voting yes. Senator DeCamp voting yes. Senator Kilgarin voting yes. Senator Warner voting no. Senator Haberman changing from yes to no. Senator Pirsch voting yes. SPEAKER MARVEL: The Clerk will call the roll.

CLERK: (Read the roll call vote as found on page 250 of the Legislative Journal). 22 ayes, 23 nays, Mr. President.

SPEAKER MARVEL: The motion lost. Okay, the next bill is LB 231.

CLERK: Mr. President, LB 231 offered by Senator Fowler. (Read title). The bill was first read on January 16 of last year. It was referred to the Judiciary Committee. It was advanced to General File with committee amendments attached, Mr. President.

SPEAKER MARVEL: Senator Nichol.

SENATOR NICHOL: Mr. Speaker, Senator Fowler is very capable and I would like to have him take the amendment too.

SPEAKER MARVEL: Senator Fowler.

SENATOR FOWLER: Okay. Mr. President and members of the Legislature, LB 231 was introduced to allow in county jails, correctional facilities that the concept of time off for good behavior, also known as good time. The bill as introduced said that once a prisoner had earned that time it could not be revoked. The Judiciary Committee felt, and I concur with this amendment, that if an inmate somehow after they have earned time off for good behavior, their behavior deteriorates, that previously earned good time could be revoked. So I would move that committee amendment, then I wish to discuss the bill and talk about some other amendments that may deal with concerns some county sheriffs may have with the bill. But I would move the Judiciary Committee amendment.

SPEAKER MARVEL: The motion is the Judiciary Committee amendment. All those in favor vote aye, opposed vote no. Have you all voted? Record the vote.

CLERK: 30 ayes, 0 nays on adoption of the committee amendment, Mr. President.

SPEAKER MARVEL: The motion is carried. The committee amendments are adopted. Do you want to explain the bill, Senator Fowler?

SENATOR FOWLER: Mr. President and members of the Legislature, it was brought to my attention last year by a rural county sheriff that there is really no provision for time off for good behavior in county jails. Usually in movies somebody gets 6 months and time off for good behavior, but in the State of Nebraska, at least in county correctional facilities that is not possible. Now at the State Penitentiary Reformatory at York that is allowed, so for the more serious crimes, the felonies, there is time off for good behavior. For the misdemeanors there is not, and so that is what the bill provides. Now there has been some concerns expressed by some county sheriffs about administration of this that perhaps they are running a very small jail, have a lot of other responsibilities, not a lot of staff and resources, and they have some reservations about implementing the bill in their county, and those reservations have been transmitted to me by their representative, Walt Radcliffe, who I am sure many of you are familiar with who represents and speaks for many people, but in this case he is speaking for the sheriffs. I talked with Walt today about possibilities to amend the bill that would solve those objections by county sheriffs in smaller counties, and it was kind of our mutual agreement that perhaps we could amend this bill so that only those counties that have a county correctional staff and office separate from the sheriff should have this provision. In the State of Nebraska right now as far as I know that is only Douglas and Lancaster County...counties with larger correctional facilities, a separate corrections staff from the county sheriff's office. The concept there is that we could put it in those larger counties, still meet any sort of constitutional test, because we are providing it in a category of correctional facilities, that is county correctional facilities, where there is a special rationale for allowing it. Unfortunately there is not enough time, that this bill...things have moved quicker on General File than expected, there was not time to draft that amendment, so I have agreed to work with Walt Radcliffe to develop the amendment, present it for your consideration on Select File, if that is acceptable, to basically allow this provision for the larger counties with correctional facilities that have correctional staff that are able to implement this. Now the administrators of both the Douglas and Lancaster correctional facilities are interested in having this bill as a mechanism of control and reward for their institutions. They find that this may, in fact, help give them an extra incentive to offer prisoners for good behavior.

So I would move to advance the bill and I pledge to present an amendment that would limit which counties it covers because there are some concerns and objections from some county sheriffs, and I would offer that for the Legislature's consideration on Select File. I would be glad to answer any questions, otherwise I would move to advance LB 231.

SPEAKER MARVEL: Senator Marsh, do you wish to be recognized on the bill? Senator Beutler, do you wish to.... Senator Kahle, do you wish to be recognized?

SENATOR KAHLE: Mr. Speaker and members, I guess I am a little concerned. Maybe Senator Fowler can enlighten me. He said that it would be constitutional because of the difference in facilities. I guess I have two questions, one is, are outstate people ever housed in the county jails that you mentioned in Omaha and Lincoln? And if they are, how would that relate to the difference in treatment from their home county? And the other thing is how do you determine how much good time they would receive? Will there be a formula?

SENATOR FOWLER: Okay. Senator Kahle, let me take the second question first. There is a formula in the bill and it is five days good time I think for one month good behavior, or seven days...seven days good time for one month behavior. So you have to have a certain continuous number of days of good behavior before you earn it, and that formula then would be uniform. As to whether people from outstate counties are housed, I would guess there may have been times that in the Douglas and Lancaster facilities there have been prisoners from other counties housed at least temporarily before they are transported maybe back to a home county. Whoever is in those facilities would, whoever is in that would earn good time if they have already been sentenced. Obviously, if somebody is waiting for sentencing, the good time could not be earned. It would be applicable after sentencing. I could check into whether any outstate prisoners have ever been housed in those facilities after sentencing. I am sure they have been used as temporary holding facilities.

SENATOR KAHLE: Thank you, Senator Fowler, and with that explanation I will wait and see what they come up with on Select File. But I think we need to be very careful that we don't make a discriminatory bill out of this so that in one section of the state or one facility you will get different treatment than you do in another. Thank you.

CLERK: Mr. President, the amendment reads as follows: On page 2, line 13, strike the word "life" and insert "safe yield."

SENATOR CLARK: Senator Vickers.

SENATOR VICKERS: Mr. President, since that is more of a technical one there the following amendment on Section two would be more applicable to take up and I think the Clerk has other amendments on Section one so if you would want to skip over this and go to the other amendments that are on Section one, that would be fine with me. You have other amendments and I think Senator Beutler and some other people might have amendments on Section one if you want to go ahead and take those up at this time.

SENATOR KILGARIN: I move the E & R amendment to LB 231.

SENATOR CLARK: You heard the motion. All those in favor say aye, opposed. The E & R amendments are adopted. The next amendment.

CLERK: Mr. President, Senator Fowler would now move to amend the bill.

SENATOR CLARK: Senator Fowler.

SENATOR FOWLER: Mr. President, members of the Legislature, when this bill was advanced from General to Select File, I indicated that I was working with the County Sheriffs

Association on an amendment that would deal with the objection of some rural sheriffs that this bill would create administrative problems within their counties, that it would not be a possibility really for them to effectively and judiciously administer this act and, therefore, responding to that argument developed an amendment that would make this bill apply only to those counties that have a County Department of Corrections, which currently is only Douglas and Lancaster County. Now the Douglas and Lancaster County Correctional administrators, Joe Vitek in Douglas County, and Pat Rackers in Lancaster County, do support this bill and do feel that it is possible for them with their administrative structure which is obviously different than in other counties, with their administrative structure to fairly and honestly and effectively administer this act. Other counties, other classes of counties may not be able to do so because they do not have the same correctional administrative structure. So what this amendment does, and it is an amendment that has been agreed to and I worked with the County Sheriffs Association would make this bill applicable only to those counties that are established with a Department of Corrections and that, therefore, those counties that have the administrative structure and the resources to administer this act would do so and we would exempt those who because of the structure of their correctional system would not be able to properly administer the program. So as I indicated when I advanced the bill from General File, I would bring this amendment, present it to you now. It is the compromise that I have worked out with the Sheriffs Association and I would urge that you adopt it.

SENATOR CLARK: Senator Nichol.

SENATOR NICHOL: Mr. Chairman, members of the Legislature, I support the amendment and certainly would think that it would relieve any pressure from smaller counties that felt they couldn't cooperate with this so I support the amendment.

SENATOR CLARK: All those in favor of the Fowler amendment will vote aye, opposed vote nay.

CLERK: Senator Clark voting yes.

SENATOR CLARK: Have you all voted? It does require 25 votes. Record the vote.

CLERK: 25 ayes, 0 nays, Mr. President.

SENATOR CLARK: The amendment is adopted. Any further amendments?
