SPEAKER MARVEL PRESIDING

SPEAKER MARVEL: The Legislature will come to order. The Clerk has some items to read in.

CLERK: Mr. President, your committee on Enrollment and Review respectfully reports we have carefully examined and reviewed LB 141 and recommend that same be placed on Select File; LB 57 (sic 50) Select File with amendments. (Signed) Senator Kilgarin, Chairman.

Mr. President, I have an Attorney General's opinion addressed to Senator Wesely regarding Nebraska Revised Statutes 32-1001.33 which will be inserted in the Journal. (See pages 342 - 344.)

Your committee on Revenue gives notice of public hearing in Room 1520 for February 2, 3, and 4. Committee on Ag and Environment gives notice of hearing in Room 1520 for February 19, 20, 26, and 27. Your committee on Public Works gives notice of public hearing in Room 1517 for February 5, March 5, 6, 11, and 12. Your committee on Business and Labor gives notice of cancellation of a hearing for February 4 and rescheduling one for February 4. Mr. President, your committee on Education whose Chairman is Senator Koch to whom we referred LB 15 instructs me to report the same back to the Legislature with the recommendation it be advanced to General File; LB 16, General File; LB 207, General File; and LB 165, General File with amendments. (Signed) Senator Koch, Chairman.

Mr. President, your committee on Banking, Commerce and Insurance whose Chairman is Senator DeCamp to whom we referred LB 238 instructs me to report the same back to the Legislature with the recommendation it be advanced to General File with amendments. (Signed) Senator DeCamp.

many many commissions and many, many boards that there are not going to be bills pertaining to that particular commission or board and, therefore, they will not be changed in this session. So I would ask you to oppose Senator Johnson's amendment.

SPEAKER MARVEL: Senator DeCamp, we are on the Johnson amendment.

SENATOR DeCAMP: Mr. President, members of the Legislature, I support the Johnson amendment. It is not all as serious as you think. In fact, if anything, it does quite simply make everything under a standard act. We've already got the Administrative Procedures Act and I think probably 99% of the agencies follow that procedure. The particular Real Estate Act as I recall had a little different variation because I think it might have been written maybe before the other one. So all you are doing is getting a little uniformity. It doesn't affect the balance of the bill and I would urge you to go ahead and put that amendment on in conjunction with the balance of the bill which is an important bill.

SPEAKER MARVEL: Okay, the motion is the Johnson amendment to LB 238. All those in favor vote aye, opposed no. Have you all voted? Record.

CLERK: 31 ayes, 1 nay on the Johnson amendment to the committee amendments, Mr. President.

SPEAKER MARVEL: The Johnson amendment is adopted. The motion now is the committee amendments as amended, the committee amendments to LB 238. All in favor of that motion vote aye, opposed vote no. Record.

CLERK: 34 ayes, 0 nays on adoption of the amended committee amendments, Mr. President.

SPEAKER MARVEL: The committee amendments as amended are adopted. Now the motion is the advancement of the bill as amended to E & R for review. All those in favor vote aye, opposed vote no. Record.

CLERK: 32 ayes, 0 nays on the motion to advance the bill, Mr. President.

SPEAKER MARVEL: The motion is advanced. The next, LB 244.

CLERK: Mr. President, LB 244 was introduced by Senator Burrows, Senator Landis and Senator Koch. (Read.) The bill was read on January 16 of this year. It was referred

to the Banking Committee for public hearing. The bill was advanced to General File. There are no amendments pending, Mr. President.

SPEAKER MARVEL: Senator Burrows.

SENATOR BURROWS: Mr. Speaker, I move the advancement of LB 244. LB 244 allows the administration to provide dental benefits in a state plan or any portion thereof to fund a program providing state employees with dental benefits or any portion thereof. It is a permissive piece of legislation. There is no fiscal impact but presently we do not have that provision and that option for the administration if it so decides to go into a dental benefit plan with state employees. I think the possibilities of this being advantageous to the state are very good. It is a way of providing the employees additional benefits without paying federal income tax where benefits become a higher part of the pay plan and I hope the Legislature advances this bill. Thank you.

SPEAKER MARVEL: Senator Koch.

SENATOR KOCH: Mr. Speaker and members of the body, I would like to call your attention to the fact that this does exclude certain individuals such as state colleges, technical colleges and the university system and those people who work at least half time or more. We are talking primarily about those people who are employed here in this building and other state office buildings. In view of the fact that we have seen fit over the past several years to minimize their increases in terms of salary and other fringe benefits, I believe it is only appropriate that we provide to these people additional health benefits to those individuals plus their families. I don't think it is unrealistic at all. We don't say we are going to provide total dental benefits but that can be a part of the package, either half or whatever the decision might be what we will recommend to this program. So I am suggesting that this body if we really believe in state employees and those who help us in our daily endeavors, I think they are deserving of some consideration other than just salaries at all times and this is not unique just to these people but if you look at the State of Nebraska many other individual citizens have this privilege in the private sector. Why not try to treat these people with some degree of equity in terms of programs that are being offered. I ask for you to support LB 244.

SPEAKER MARVEL: Senator Higgins.

SENATOR HIGGINS: Would Senator Burrows yield to a question, please?

SPEAKER MARVEL: Senator Burrows, do you yield?

SENATOR BURROWS: Certainly.

SENATOR HIGGINS: Senator Burrows, is the state employees' insurance funded entirely by the state or do the employees make any contribution?

SENATOR BURROWS: On this one?

SENATOR HIGGINS: Yes, on the dental bill, would the employees have to pay part or would the state pay all of it?

SENATOR BURROWS: This bill would provide the option for the state to provide what it decided. It could be a portion or the entirety of the plan. The bill is open in this. It could be a portion, any portion or the entirety provided by the state if the state so chooses to provide a plan.

SENATOR HIGGINS: At the present time, do you know, Senator, if the hospitalization plan that state employees have is totally state funded or not?

SENATOR BURROWS: It is a split, the present health insurance but the state does not for these employees provide any dental insurance at the present time. The health insurance plan is a split as a precedent by the employee and the state both contributing into the health insurance plan.

SENATOR HIGGINS: One more question, if the state should so decide to allow them dental insurance, would it be mandatory? In other words, would those employees who do not want it have the option of not purchasing it? In other words, what I am thinking of, is some of the state employees' salaries are so low that if they had to buy the dental health insurance, it would be another deduction from their salary and they just might not be able to afford it, so do you think it would be mandatory that they all buy it or would those who didn't want it be allowed not to buy it?

SENATOR BURROWS: Well the way I understand it and if someone knows differently they could correct me. Presently the state provides the entirety on the single employee but this bill provides an option and would not mandate what the administration or the state decided to provide for a plan and I would hope that they would not mandate participation by employees that did not want the plan.

SENATOR HIGGINS: Well let me ask you this then as a freshman. If the state would decide to put in this dental health plan, we would have the option of putting an amendment in, wouldn't we, that it wouldn't be mandatory for those who did not want to buy it?

SENATOR BURROWS: We certainly would.

SENATOR HIGGINS: Okay, thank you, Senator.

SENATOR BURROWS: Thank you.

SPEAKER MARVEL: Senator Cope and then Senator Rumery.

SENATOR COPE: Mr. President, members, this will be a fiscal impact later on if the program should be decided upon and we must remember that. It also is a fiscal impact on the employee and I certainly do think they should have the privilege of decision as to whether they want it, but the problem there is if other employees are getting half of it paid and they don't...they decide not to do it on their own, in a sense they are paying part of those employees who have gone along with the program. It is sort of like federal aid, if we don't take it, somebody else will get it so we better take it. I have mixed emotions on this. On the surface it sounds great but I would like to know what the fiscal impact would be if the decision was made to accept this plan.

SPEAKER MARVEL: Senator Rumery.

SENATOR RUMERY: Mr. President, members of the Legislature, I would like to ask Senator Burrows a question if I might.

SENATOR BURROWS: Certainly.

SENATOR RUMERY: We have stamped across the top of this bill, "No Fiscal Impact." Is that quite a correct statement? As I read it I thought there would be some fiscal impact on the state treasury.

SENATOR BURROWS: Yes, that is correct. There is no fiscal impact because this does not provide the dental health care insurance. This provides the option to the state if the administration so desires to in the future make it part of the salary package and what I would like to bring out. It does not necessarily involve a fiscal impact in excess of what the salary situation would be because certainly in the administration or the Governor's side when they come to setting up a salary increase, that will be taken into consideration in total with the health benefits, the dental health insurance and undoubtedly a lesser amount of salary increase will

come up for consideration if a costly dental health care provision comes in. So it might be implemented in a future year without a total impact on the budget whatsoever if they decided to take and it is wide open as to the percentage of cost that might be involved. They will undoubtedly consider this in future salary raises. So in a total package it does not necessarily entail a fiscal impact. It could but does not involve that necessarily for the future and would not this year.

SENATOR RUMERY: But we do not know for sure but what there would be a fiscal impact in future years then?

SENATOR BURROWS: No, this obviously is here. If the administration or the Governor's office decided to give a portion of dental benefits in addition to what they would be giving, say in salary increase, that would involve a fiscal impact but I think it is very doubtful that the Governor's office is going to give this without consideration back on the salary increase and the fiscal impact is definitely unknown what it might be in future years.

SENATOR RUMERY: But as of this year there would be no fiscal impact on the state treasury then?

SENATOR BURROWS: That is correct.

SENATOR RUMERY: Thank you.

SPEAKER MARVEL: Senator Burrows, do you wish to speak again?

SENATOR BURROWS: No.

SPEAKER MARVEL: Senator Remmers.

SENATOR REMMERS: Mr. Chairman, members of the Legislature, I would like to support this bill. We are speaking of the fiscal impact it has right now. I believe as Senator Burrows has explained that this would be a matter of negotiations that the state can use in negotiating with the employees. I think it is a measure that state employees deserve. I believe we all realize that group dental insurance or group insurance of any kind is cheaper than individual insurance. I know that in the education field that teachers, many teachers have had it for a long time. In our school we've had the dental insurance included for a long time and I think the state employees deserve an opportunity to have group dental insurance and it can be used as a negotiating item for the state.

SPEAKER MARVEL: Senator Wagner.

SENATOR WAGNER: I have a question of Senator Burrows if he will please.

SPEAKER MARVEL: Senator Burrows, do you yield?

SENATOR BURROWS: Certainly.

SENATOR WAGNER: Senator Burrows, I guess for my own edification approximately how many people could this affect, how many state employees? Do you have any idea?

SENATOR BURROWS: Approximately fifteen thousand.

SENATOR WAGNER: About fifteen thousand. Do you have any idea then how much the employee might pay in if this were to go through?

SENATOR BURROWS: Well this would be up to the administration in deciding the package that they agreed on. The maximum dollar involvement would be approximately \$3,000,000 or slightly over which would involve, if you were comparing this back with salary increase, a maximum if fully covered of approximately 1½% salary increase. Now I think the most logical combination would be a lesser factor or a shared basis if the state decides to enter in as a portion of the benefits-salary package in a future year, the probability I would think would be a lesser or a fraction of 1% salary increase involvement across from this as you went into it in a future year.

SENATOR WAGNER: Could you put that in terms of like dollars per month per individual?

SENATOR BURROWS: Well on an option one, single, we have \$4 per month; option two, five; and option one, family plan of \$17.50; option two, \$21.44 per month.

SENATOR WAGNER: Okay, thank you very kindly.

SENATOR BURROWS: The figures I gave were the most expensive plan possible and what I think is realistic to look at is a fraction actually of 1% salary increase in total dollar involvement if the state goes into a health plan rather than as high as a percent and a half which would be full coverage by the state.

SENATOR WAGNER: Okay, thank you, Senator.

SENATOR BURROWS: Thank you.
