SPEAKER MARVEL PRESIDING

SPEAKER MARVEL: The prayer this morning will be given by Reverend Roe, the United Methodist Minister affiliated with the Trinity Methodist Church in Lincoln, Nebraska. Reverend Roe.

REVEREND ROE: Prayer offered.

SPEAKER MARVEL: Roll call. Item #3. Will you please record your presence if you haven't already. Record your vote.

CLERK: There is a quorum present, Mr. President.

SPEAKER MARVEL: Ready for item #3?

CLERK: Yes, sir. Mr. President, first of all, corrections to the Journal. (Read corrections to the Journal as found on page 220 of the Legislative Journal.)

Mr. President, I have an Attorney General's Opinion addressed to Senator Sieck regarding LB 58. (See pages 220 and 221 of the Legislative Journal.) I have a series of reports, the first from Frank Marsh, the State Treasurer, regarding the detailed statement of the condition of the State Treasury.

Mr. President, a communication from the Metropolitan Technical Community College regarding LB 1004; a communication from the State Department of Correctional Services regarding program evaluation of the therapeutic community at the Lincoln Correctional Center.

SPEAKER MARVEL PRESIDING

SPEAKER MARVEL: Okay, we are ready for item #5, Select File. You will note that there is a designation of one hour and then we will move to item #6 which has to do with reconsideration of LB 143. Okay, Mr. Clerk.

CLERK: I have nothing further on the bill.

SPEAKER MARVEL: Senator Hefner.

SENATOR HEFNER: Mr. President and members of the body I rise to support the bill as amended. I think this is the proper way to go. If you remember the other day when we were debating LB 206, Senator Chambers' bill, and we were attempting to override the Governor's veto and we were successful in doing that. I think that was the wrong way to go, but I believe now this will do what we want it to do and this is to be reimbursed for our expenses while we are doing the duties of a legislator. I would urge you to vote in favor of this bill.

SPEAKER MARVEL: The motion is the advancement of the bill to E & R Initial. All those in favor vote aye, opposed vote no. Record the vote.

CLERK: 25 ayes, 7 nays on the motion to advance the bill Mr. President.

SPEAKER MARVEL: The motion is carried, the bill is advanced. We go to 291, Mr. Clerk.

CLERK: Mr. President, LB 291 was introduced by Senator Merle Von Minden. Read title. The bill was read on January 19th of this year. It was referred to the Agriculture and Environment Committee. The bill was advanced to General File. There are committee amendments pending by the Ag and Environment Committee, Mr. President.

SPEAKER MARVEL: Senator Haberman, do you want to handle the committee amendments?

SENATOR HABERMAN: I'm not on the Agriculture committee Mr. President, but Senator Von Minden will be glad to handle them.

SENATOR VON MINDEN: Mr. Speaker and members of the Legislature, there are only two amendments on the bill, one to extend the operating date for one year in order to comply with the can company to use their supply and to gradually retool and the other one is to insert the word "carbonated". In other words the pop is just carbonated pop to get away from the soft drinks of the orange juice and grape juice in the refrigerator's of the homes. I move the adoption of the amendment.

SPEAKER MARVEL: The motion is the adoption of the Von Minden amendment to LB 291. All those in favor of the adoption of those amendments vote aye, opposed vote no. Record the vote.

CLERK: 28 ayes, 1 nay on the adoption of committee amendments.

SPEAKER MARVEL: The motion is carried, the amendments are adopted. Do you want to explain the bill now.

SENATOR VON MINDEN: Yes. LB 291 it simply states that it prohibits the dangerous removal tabs on pop and beer cans. Two years ago in one of the western cities here in Nebraska, my wife and I were in the Holiday Inn, was in the dome and watched a girl get her foot cut bad on a tab in the swimming pool. I thought what a senseless injury to this young person. From that time on I started observing where tabs from beer cans and pop cans were being thrown. They throw them in swimming pools and naturally in the flower pots, the shrubbery in the Holidome, on streets, in parks and I even picked up one yesterday on the table over here. If you will note how sharp and curved it is. The hazard that we have to people is injury by some people throwing them in the cans, some people throw them where people can step on them and it is also a small litter bill. I have a bunch of facts and figures here but I don't really think that I will go through with them right now. Industry hasn't opposed this bill simply because they have the technology to easily change to safer forms of openers. There will be no impact to the state, very little impact to the consumers by lengthening this out another year. I would also like to mention one other thing. In travelling back and forth from my home in Allen, I noticed that people are starting to pick up the aluminum cans on the highways and the road sides. I think that it is only common sense to recycle the whole can instead of just 95% of it. So with that I urge the advancement of 291 as amended.

SPEAKER MARVEL: Senator DeCamp.

SENATOR DeCAMP: Mr. President and members of the Legislature, I strongly support the bill. It is my understanding that the bill is not opposed by those people who are currently, would be in violation of it. I'll tell you a real quick little story one of the reasons I got interested in this. The little gal there, the blonde gal named Kelly Meyer has a little sister named Robin and Robin pulled the cap off the can like we all do and did the same thing I do, she dropped

it inside the can. That is the way I always do it, instead of throwing them out you just drop them in the can. A little while later Robin swallowed the darn thing and ended up in the hospital under all kinds of difficult conditions, having to get the darn thing removed and out of whatever it goes into. I think that it is dangerous. It is a little bill that will clear it up in a little over a year. I urge you to support the bill. As I said there is no opposition from the people that you would think would normally be opposing it and it is a good step forward in cleaning up litter, which we are all concerned about.

SPEAKER MARVEL: Senator Beutler.

SENATOR BEUTLER: (no response).

SPEAKER MARVEL: Senator Vard Johnson.

SENATOR V. JOHNSON: I, too, Mr. Speaker, want to rise in support of this bill. I think it is, as Senator Von Minden points out, a very minor mini litter bill, but it is one of those pieces of litter that simply could be eliminated by requiring the can manufacturers to use the non-removable tops. I should point out however that I personally have had a considerable amount of difficulty with the non-removable tops. I have found them far more difficult to use than those that you can rip off the can. Now I don't put my tops in the can and then swallow them but rather I find that I cut my fingers and the like on the non-removable top. Notwithstanding my "klutziness" and my inability to get the job done correctly, I think that this is a good measure.

SPEAKER MARVEL: The motion is to advance the bill. Senator Kahle.

SENATOR KAHLE: Mr. Speaker and members, just a question of Senator Von Minden or whoever might be able to answer it. I guess I am surprised that there is no opposition because I would guess that that type of can top that you are talking about is patented and there will have to be some changes made in some of the plants that make aluminum cans. Can anybody give me some information on this? Is that a patented top and will there be some difficulty in getting every can sales outfit, people that sell cans from all over the United States to comply? Has there been any. . . Senator Von Minden do you know of any problem?

SENATOR VON MINDEN: Senator Kahle, I met previously, earlier on the bill and the different can companies will go along

with the bill. As long as I extend the operating date another year so they can use up all of their surplus and gradually retool over, they have no objections to the bill.

SENATOR KAHLE: I'm thinking generally of those cans that may be shipped clear from some other part of the country and sold in Nebraska. Are they going to be willing to comply?

SENATOR VON MINDEN: If they want to sell in Nebraska and I think the Continental Can Company is perhaps is more than just in Nebraska and they are going along with the bill.

SENATOR KAHLE: They haven't complained?

SENATOR VON MINDEN: No, they have not.

SENATOR KAHLE: Okay, thank you.

SPEAKER MARVEL: Senator Marsh.

SENATOR MARSH: A short comment to my fellow legislators. A number of the companies have already started using these new can tops. Our family has experienced them the last three times I have gone to the store. So I think this is a good piece of legislation and it certainly is the new direction which all cans are attempting to take. I urge your advancement of 291.

SPEAKER MARVEL: Senator Dworak.

SENATOR DWORAK: Mr. Speaker and colleagues, Senator Von Minden, I congratulate you on this bill. I introduced a similar bill, I think it was three years ago, and had all kinds of opposition from the industry. Now I urge you to look at another bill that when they throw the cans with the tops attached into the ditches it might create an incentive to pick those up. Apparently your success and expertise is of note and I would like to have you carry a bottle bill next year. Since I was unsuccessful on this bill three years ago and have been consistently unsuccessful on the bottle bill, I wish you best and urge you to continue the good fight.

SPEAKER MARVEL: Senator Haberman.

SENATOR HABERMAN: Mr. President, Mr. President, fellow colleagues, please, please vote for this bill. I have sat by this fellow for some fifty days now. I have looked at the

tie clasp, for fifty days I have looked at the tie clasp and I have heard the story about this. I fully support it and please, if you don't vote for Von Minden, give me a vote and advance 291.

SPEAKER MARVEL: Senator Cullan.

SENATOR CULLAN: Mr. President, members of the Legislature, I have some mixed emotions about this bill because often times when I have a friend here from western Nebraska and he came down and I asked him what he thought about this bill and he said he didn't particularly like it because he is not the most coordinated person in the world, he used to play football with me so I know that he is not particularly coordinated. Whenever he opens them he says he can open the regular kind without spilling pop all over himself but the new more complicated kind give these big football players from western Nebraska a little difficulty. But I guess despite the intense lobbying I have had from the one constituent in the building today I guess I voted against Von Minden every chance I have had this session so maybe I will give him a break this time.

SPEAKER MARVEL: Before we go to Senator Wesely, underneath the north balcony, someplace underneath the north balcony, is Kevin Sorenson from Hemingford. Where are you Kevin? Senator Cullan's bodyguard I would say. A classmate of Senator Cullan, Class of '72, Hemingford High School. Welcome to the Unicameral, Kevin. Senator Wesely.

SENATOR WESELY: Mr. Speaker, I would like to have a chance to ask Senator Von Minden just a quick question.

SPEAKER MARVEL: Senator Von Minden.

SENATOR VON MINDEN: Yes.

SENATOR WESELY: Your amendment which we adopted took the word "carbonated" and included that as a qualifer as to what soft drinks would be covered under this act and I'm concerned as to what would that exclude then? What sort of soft drinks are we now not going to cover as a result of that amendment?

SENATOR VON MINDEN: I don't know if it is soft drinks. It is such things as orange juice, the grape juice, the V8 juices that are in the wife's refrigerator, that would be an awful expense to put them into the tab that we don't throw away.

SENATOR WESELY: You don't see a problem with that then? You think that is fine.

SENATOR VON MINDEN: Senator Haberman, I did promise him that I would throw this one away and wear one "you can't get off the can" tomorrow. Senator Sam Cullan out there, I think the football players would have enough strength to push the can in. I move to advance the bill.

SPEAKER MARVEL: All those in favor of the motion to advance the bill vote aye. Opposed vote no. Have you all voted? Record the vote.

CLERK: 34 ayes, 0 nays on a motion to advance the bill
Mr. President.

SPEAKER MARVEL: The motion is carried, the bill is advanced.
