CLERK: (Roll call vote taken. See page 1194, Legislative Journal.) 24 ayes, 21 nays on the motion to indefinitely postpone, Mr. President.

SPEAKER MARVEL: Okay, the bill is deceased. The Call is raised.

CLERK: Mr. President, while we are waiting, your committee on Enrollment and Review respectfully reports they have carefully examined and reviewed LB 384 and recommend that same be placed on Select File; LB 59, Select File, 168, Select File and LB 168A, Select File. (Signed) Senator Kilgarin, Chair. (See pages 1195 and 1196 of the Legislative Journal.)

SPEAKER MARVEL: The next order of business is LB 292.

CLERK: Mr. President, LB 292 was a bill introduced by Senators Maresh, DeCamp and Kilgarin. (Read title.) The bill was first read on January 19. It was referred to the Government Committee. The bill was advanced to General File and I do have committee amendments pending by the Government Committee, Mr. President.

SPEAKER MARVEL: Senator Kahle.

SENATOR KAHLE: Mr. President and members, the committee amendments are basically the bill now, and, of course, the bill was heard before the Government, Military and Veterans Affairs Committee on February the 12th. If you look in your bill book, you will see the procedure that was taken. This is a forms management bill and, of course, in order to explain the amendment I almost have to explain the bill, and I am sure that those that introduced it will be a little bit more informed than myself. But it seems that we have a great number of forms in the procedure of state government. And I think you have all heard complaints over the years that, my gosh, how many forms do we have and how many do we have to fill out to get something done? In our education system, in our... anything that you do in the State of Nebraska or perhaps anywhere else for that matter, you have an enormous amount

of forms to fill out and we have passed out some information or I think Senator DeCamp passed it out and some of you have this on your desk which show that there were some I believe 12 or 14 forms that all did the same thing and then on the next back page of that same hand-out you see what would happen if you went to a new forms management act and you would have one form that would do all the things that those others did. A number of other states have gone to this system and, of course, the Director of Administrative Services would be in charge of this. We have had some discussion with the different departments in state government. Some were a little less than hot about this idea at first but I believe we have all the wrinkles out of it now and there is, of course, some cost to it to get it started, but after that it should make the state some money. So I do move the amendments to 292. Thank you.

SPEAKER MARVEL: The motion is the adoption of the committee amendments on LB 292. All those in favor of adoption of those amendments vote aye, opposed vote no. Have you all voted? Record the vote.

CLERK: 26 ayes, 0 nays on adoption of the committee amendments, Mr. President.

SPEAKER MARVEL: The motion is carried. The committee amendments are adopted. Now before we go to the next item, underneath the south balcony it is my pleasure to introduce Steve Marsh from Washington D.C. Steve. Okay, Senator Maresh.

SENATOR MARESH: Mr. Speaker and members of the Legislature, LB 292 is the result of an interim study that was conducted by the Business and Labor Committee and the Government, Military and Veterans Affairs Committee, Chaired by myself and Senator DeCamp. We jointly tried to find out what we could do to help the small businesses, and this was one area we felt we could do a lot by cutting down on the amount of paper work they have to handle to comply with government forms on the state level. We held a hearing during the interim and we decided that we should do something. And then the Governor had his conference on small businesses last December and that was one of the topics that was discussed at length, how they have to fill too many forms. So we, Senator DeCamp and I, decided to sponsor this bill, and the bill didn't have any opposition at the hearing. Only one person from the Department of Education opposed the bill. Otherwise, everybody appearing in favor. This would place it under

the DAS to have the agency take care of this. The Governor has decreed that all state agencies should work toward this end to do away with a lot of forms. We found at the hearing that the Welfare Department has one person that is assigned to just drafting forms, and we thought this was unthought of to have one person just designing forms. So now this will cut down on forms greatly. We have reports from the State of Washington who has had this act on since 1973, that since this law was enacted, they saved three and a half million dollars in direct cost and twenty-one and a half million dollars in indirect savings. That pertains to the businesses, they feel that this forms management act has saved that much to the businesses and the individuals affected by filling out forms, commodities, or surveys and things like that. Now if this comes about, if we pass this bill, it will be supervised by DAS and no form after July 1st, 1982 will....you will have to be required to fill that....you won't be required to fill that form unless it has the seal of approval from DAS. In the State of Indiana they have a law like this and this was passed in 1978, and at that time there were 68,000 separate forms to run their state government, and since 1978 that number has been reduced to 42,500 with another 10,000 that are targeted for extinction this year. They save approximately \$500,000 per year and they will have saved...they figure they are going to save \$13 million. So you can see that there is a great savings to be found by having a forms management act. The reason that we have decided to do this by statute instead of having the Governor do it by decree is because when there is an administration change, we want this to carry on and not be abolished. So I move that this bill be advanced to E & R Initial.

SPEAKER MARVEL: Senator Kilgarin.

SENATOR KILGARIN: Thank you, Mr. Chairman and members of the Legislature. A lot of hours were put in on LB 292 and now that the committee amendments are adopted, Bob Beecham, the only opponent to 292 worked on those amendments and is now satisfied with the form that 292 is in. So the opposition has been cleared up and, as a matter of fact, he worked on the amendments. I would urge your support of 292.

SPEAKER MARVEL: Senator Higgins.

SENATOR HIGGINS: Mr. President, I would like to ask Senator Maresh a couple of questions.

SPEAKER MARVEL: Senator Maresh, will you yield?

SENATOR MARESH: For everybody except the University and the state colleges. I forgot to mention that, because....

SENATOR HIGGINS: That's my first question.

SENATOR MARESH: Okay, they are independent in the Constitution so we felt....I guess the committee took them out by amendment.

SENATOR HIGGINS: So they would still have their own forms?

SENATOR MARESH: Yes. We found out by a Supreme Court case that we cannot tell the University what to do.

SENATOR HIGGINS: I don't think anybody can. The second question I've got is under Section 5 it says, "establishes the duties and functions of the Director". Does this mean we are going to be hiring a new person?

SENATOR MARESH: No, Director of DAS. He is called Director in the bill.

SENATOR HIGGINS: In other words, we are not going to create a whole new program, and....

SENATOR MARESH: No, that's what the committee was concerned not to establish....

SENATOR HIGGINS: ....new jobs.

SENATOR MARESH: That's what the committee was concerned about not establishing any more departments. So it is placed in DAS and the Director is the Director.

SENATOR HIGGINS: Okay, thank you, Senator.

SPEAKER MARVEL: Senator Mares, are you going to advance the bill?

SENATOR MARESH: I move that LB 292 be advanced to

CLERK: Mr. President, LB 292A is a bill offered by Senator Maresh. (Read title.)

SPEAKER MARVEL: Senator Maresh, do you want to advance the bill?

SENATOR MARESH: Yes, Mr. Chairman, I move that this bill be advanced. This is to carry out the functions that we need the first year.

SPEAKER MARVEL: The motion is to advance 292A to E & R for Review. All those in favor vote aye, opposed vote no. Record the vote.

CLERK: 30 ayes, 0 nays on the motion to advance 292A, Mr. President.

SPEAKER MARVEL: The motion is carried. The bill is advanced. The next bill, LB 479.

CLERK: Mr. President, LB 479, offered by the Revenue Committee and signed by its members. (Read title.) The bill was first read on January 20, referred to Revenue. It was advanced to General File. There are committee amendments pending, Mr. President.

SPEAKER MARVEL: Senator Carsten.

SENATOR CARSTEN: Mr. President and members of the Legislature, I move for the adoption of the committee amendments. The committee amendments do really two things. Number one, it would provide if the counties' failure to implement a valuation manual, it must be established by the examination of the counties' valuation books and records, and second, that the values resulting from the tax commissioner's corrective action shall be used and may be appealed as other new values and property owners would be notified of valuation changes. The basic reasoning behind the bill and the amendments is this, that in

SPEAKER MARVEL: The next order of business is Final Reading, item #4. All legislators will please take your seats so we can proceed with Final Reading. All unauthorized personnel please leave the floor. The first bill on Final Reading is LB 179E. Senator Koch, your light is on, did you wish to be recognized? Okay. LB 179E.

CLERK: Mr. President, I have a motion on the desk. Senator Hoagland moves to return LB 179 to Select File for a specific amendment, and there are copies that have been distributed, Mr. President.

SENATOR HOAGLAND: Mr. Speaker and colleagues, we had intended to have this printed in the Journal but we adjourned abruptly enough yesterday so it was not done, and I apologize for that. I would ask you to turn to page 19 of the bill. This is an amendment which is of a technical nature basically, in my opinion, and I apologize for holding up final passage of a bill as long as this to get this change made or to seek this change made but I think it is important enough to do it. If you turn to page 19 and review Section 12 of the bill, there is an inference there in that section that if there is a lawsuit filed against a public employee or public official and that lawsuit is successful, why then the public official or public employee has to pay the entire damages out of his own pocket if the jury in that lawsuit or the court in that lawsuit finds that his action was not reasonable or that his action was not in good faith. Now, what the amendment would provide is that the political subdivision that he is working for will pay the judgment against him as long as he operated...let me get the language here, within the scope of his office or employment. The amendment goes on to provide that there is nothing that should be construed to prevent the discipline of an employee or an official who does not act reasonably and in good faith in the performance of his duties. Now the reason I think this is important is because if this particular provision stays in the law, in my opinion it is going to scare the living daylights out of a lot of public officials and a lot of public employees and they are not going to execute their statutory functions as they should. Now let me try and give you two examples of why I think this could have a detrimental

about \$192,000 which is money that is given to parents who transport their children who are handicapped. I ask for the deletion of this part of LB 317.

SPEAKER MARVEL: Okay, the motion is to strike Section 8 of the bill. Senator Wagner, do you wish to speak to that motion?

SENATOR WAGNER: Yes. Mr. Speaker and members, I certainly support Senator Koch's amendment up there because it is strictly just a duplication like he indicated, and, therefore, I support the amendment.

SPEAKER MARVEL: The motion is the adoption of the Koch amendment as explained by Senator Koch, to LB 317. Do you want to close, Senator Koch? Okay, all those in favor of the Koch amendment to LB 317 vote aye, opposed vote no. Record the vote.

CLERK: 26 ayes, 0 nays, Mr. President.

SPEAKER MARVEL: The motion is carried, amendment is adopted.

CLERK: I have nothing further on the bill, Mr. President.

SPEAKER MARVEL: Excuse me.

CLERK: I have nothing further on the bill.

SPEAKER MARVEL: Do you want to advance it? Okay, Senator Kilgarin.

SENATOR KILGARIN: I move LB 317 be advanced to E & R for Engrossment.

SPEAKER MARVEL: All in favor of that motion say aye, opposed no. The motion is carried. The bill is advanced. The next bill is 292.

SENATOR KILGARIN: I move the E & R amendments to LB 292.

SPEAKER MARVEL: All those in favor of that motion say aye....

SENATOR KILGARIN: I also move to amend the E & R amendments to 292 as follows: "In Section 2, line 2 strike 'Farms' and insert 'Forms'." F-o-r-m-s.

CLERK: Mr. President, Senator Maresh moves to amend the bill by adding the emergency clause.

SPEAKER MARVEL: Senator Maresh.

SENATOR MARESH: Mr. Speaker and members of the Legislature, this would expedite the performance of the various departments in state government to get on the ball and start enacting this law, and they could start working on it sooner. I move that this emergency clause be added to the bill.

SPEAKER MARVEL: Okay, the motion before the House is the adoption of the emergency clause to LB 292. All those in favor of that motion vote aye, opposed vote no. We're voting on the E & R amendments to 292 as proposed by.... the emergency clause as proposed by Senator Maresh. Have you all voted? Is there anybody who has not voted who wishes to vote? Senator Maresh. Senator Maresh.

SENATOR MARESH: How many are excused?

SPEAKER MARVEL: There are four excused.

SENATOR MARESH: It appears that they don't want to vote I guess, so what do you want to do, John? It's your bill too. Karen, what do you want to do?

SENATOR CLARK: I would like to announce the guests of Phyllis Todd from Senator Beutler's District, Mr. Kim, Mrs. Kim and Mrs. Bae-Pusan from Seoul, Korea. They are under the south balcony. Will you stand and be recognized, please? They are in the south balcony. Welcome to the Legislature. LB 243.

CLERK: Mr. President, LB 243 was a bill introduced by Senator Schmit. (Read title.) The bill was first read on January 16, referred to Ag and Environment. The bill was considered by the body on April 10, Mr. President. At that time the committee amendments were adopted. There was an amendment from Senator Schmit that was adopted. The bill failed to advance on that date, Mr. President. I have nothing further on the bill.

SENATOR CLARK: Senator Schmit.

SENATOR SCHMIT: Mr. President and members of the Legislature, I am going to ask you once again to consider LB 243. The bill was heard and discussed and debated at length. The previous time it was up it received 23 votes to advance on a Friday afternoon with about 27 or 8 people on the floor. I think that the fact that we have discussed the bill should perhaps wipe out any reason for a lot of lengthy debate. I know there are a lot of other bills that you want to get to today. I just want to say in reply to a piece of material that is lying on your desk, two and a half pages in length, which casts serious doubts about the problems that LB 243 can cause, I want to say this. You will recall that Senator Kremer and myself and along with several...at least 23 others in this body successfully added about \$2 million to the water development fund. There are rumors now that they may want to cut that back in the Executive Office to \$3 million from 4. That means that we will have about an additional \$800,000 in the water development fund, 50 cents per capita. Not exactly an overwhelming amount of public support I would guess for water development. My concern as I have indicated many times on this floor is this, if we are going to use funds that have been generated by a subdivision of government for

Senators Peterson, Nichol, Burrows, Lowell Johnson, and Sieck would like to print amendments to 512; Senators Beutler and DeCamp to LB 352.

SENATOR NICHOL: Senator Lamb and Senator Carsten are the two that are not here yet. Senator Koch.

SENATOR KOCH: Mr. Chairman, can we take call in votes and speed this up?

SENATOR NICHOL: If you would like.

CLERK: Senator Chronister voting yes. Senator Hefner voting yes. Senator Hoagland voting yes.

SENATOR NICHOL: Record, Mr. Clerk.

CLERK: 26 ayes, 19 nays, Mr. President, on the motion to advance the bill.

SENATOR NICHOL: The bill is advanced.

CLERK: Mr. President, finally, the last item I am going to read in is a new resolution offered by Senators Kremer, Haberman and Rumery. (Read. See page 2092, Legislative Journal.) That will be laid over, Mr. President.

And, Mr. President, I have notice of hearing from Senator Warner regarding a meeting of the special committee regarding Federal-State-Local Fiscal and Program Policy.
