SPEAKER MARVEL: The motion is carried and the amendment is adopted. The cookies underneath the balcony are brought here by the Nebraska Federation of Women's Clubs in the state. Senator Newell.

SENATOR NEWELL: Mr. President, members of the body, LB 37 as amended, the amendments basically just clarify, put back the old language. There was an attempt by myself as the introducer to, as one of the cointroducers to try to clarify the language and in so doing we made it less clarifying so the committee amendments go back to the old language and what we are doing here is very simply just authorizing that the votes, when one votes for the homeowner directors after a period of time who was supposed to be serving on the board, those people can only vote one vote per resident as opposed to one vote per lot and that just clarifies the language. There was some problems. This is the intent of the legislation originally. When Senator Cavanaugh, then Senator Cavanaugh, introduced the bill, it goes back to the original intent to make it a partial control by residents. This bill was not controversial. It was not opposed by the homebuilders who usually oppose anything that would change SIDs. It is just a clarification so with that, I urge the movement of the bill.

SPEAKER MARVEL: The motion is the advancement of LB 37 as amended. All those in favor vote aye, opposed vote no. Record.

CLERK: 31 ayes, no nays, Mr. President, on advancement of the bill.

SPEAKER MARVEL: The motion is carried. The bill is advanced. The next motion, LB 30.

CLERK: Mr. President, LB 30 was offered by Senator Jerry Koch. (Read title.) The bill was first read on January 8. It was referred to the Urban Afffairs Committee. The bill was advanced to General File. I again have committee amendments pending by the Urban Affairs Committee, Mr. President.

SPEAKER MARVEL: Senator Haberman, do you want to take up the committee amendments to LB 30? Senator Landis, do you want to take the amendments? We are on LB 30 and we need an adoption of the committee amendments.

SENATOR LANDIS: Mr. Speaker, members of the Legislature, this bill comes to us from the Omaha area with an SID that has had serious problems with obtaining the consent of the Omaha City Council and Mayor for the construction of a community center and the language of the bill intends to

allow for the decision to be made by the city council but to do away with the ability of the mayor to veto such an ordinance. The ordinance would be effective upon the majority vote of the council without necessarily the signature of the mayor. The testimony in the hearing was extensive as to the experience of this SID and the committee reported the bill out. The amendments that are offered by the committee were offered to the committee by the representatives of the bill, Robert Huck, who is an SID attorney, attorney for SID 95. They described the areas in which this kind of extraordinary procedure would apply and that would be in ordinances concerning a public park, playground or recreation facility improvement in an SID and it also adds to make it very explicit the language, "Governing body of such municipality in this case, Omaha, or county shall, the approval shall not be subject to any veto." It takes the executive out of the decision. It leaves the city council as the deciding body for the ordinances that would create or allow in SIDs public parks, playgrounds or recreation facilities. I move the adoption of the committee amendments.

## SENATOR CLARK PRESIDING

SENATOR CLARK: Is there any discussion on the adoption of the committee amendments to LB 30? If not, all those in favor vote aye. All those opposed vote nay. Have you all voted? Record the vote.

CLERK: 31 ayes, 0 mays on adoption of committee amendments, Mr. President.

SENATOR CLARK: The motion passed. The committee amendments are adopted. Senator Koch, what do you wish to do with the bill? We have two other amendments first, Senator Koch. The Clerk will read the amendment.

CLERK: Mr. President, first of all, Senator Newell offers an amendment found on page 410 of the Legislative Journal.

SENATOR CLARK: Senator Newell.

SENATOR NEWELL: I think I am going to withdraw this but I want to make sure it is the right amendment so if I could just look at 410 for a second. Mr. President and members of the body, I would like to withdraw this amendment at this time and if my second amendment is adopted, then I will not offer this amendment to the body.

SENATOR CLARK: The amendment is withdrawn. The Clerk will read the next amendment.

CLERK: MR. President, Senator Newell moves to amend: (Read Newell amendment as found on page 443 of the Legislative Journal.)

SENATOR CLARK: Senator Newell.

SENATOR NEWELL: Mr. President and members of the body, this is my honest attempt to try to keep the principle and yet allow the purpose of this bill to be accomplished even though I may not be in total agreement with that purpose. I offer this amendment. It is a one year sunset provision. That means that in this case we will allow the purpose of this bill to be effective but after one year this very bad principle will be sunsetted. With that, I urge the body to accept this amendment.

SENATOR CLARK: Senator Landis.

SENATOR LANDIS: Mr. Speaker, members of the Legislature, I am hoping that Senator Koch at some time soon will get a chance to trace for you the experience of this SID that this bill comes from. I certainly have questions as to the underlying policy of taking out an executive in a choice like this. It is not good textbook law. It is not good political science organizational chart decisionmaking, however, the experience is so convoluted, it is such a good faith attempt by people to control their own environment and face unlimited frustrations by City Hall, it is the case that the specific justifies the general change. It is a hard case and we may be making a questionable law but I would agree with Senator Newell that the sunset provision would be a wise one. It frankly is being passed for one specific circumstance. I do not want to hold out that it is anything other than that. This is, as one of my colleagues called it, a Burger Chef law made to special order and if we are going to go that far, we may as well put a sunset provision on it so that we don't wind up with this policy over a long period of time. But I do support Senator Newell's amendment because it limits the operation of what is, in fact, a very specially designed law to solve a particular problem and we are not going to be stuck with this policy over a long term with Newell's amendment so I support it.

SENATOR CLARK: Senator Koch.

SENATOR KOCH: Thank you, Mr. Chairman. I appreciate the remarks of Senator Landis. I know this is a bill with some problem, however, as Senator Landis indicated to you that SIDs are a creature of the Legislature, Senator Newell alluded to the fact that in 1975 Senator Cavanaugh along with a number of us introduced legislation that affected

SIDs and their control and their functions. This SID which is in my district is a little west of where I live, has over two thousand people who live in it. It is fully developed and for the past seven or eight years these people in good faith have been trying to meet all the standards that is placed before them by the law and by the city. They have been before the Planning Works Committee, they have been before the Planning Board, they have met the master plan of the county and the city, they have done everything. They have even increased their own mill levy to pay off their indebtedness at a greater rate. The valuation of this SID is \$18,000,000 and so you see it is an SID with considerable wealth. These people by 95% of the residents have stated very clearly in petitions that they are willing to obligate themselves for a community center. This community center is not only available to those individuals but would be available to approximately thirty thousand people of the area and if you know this area at all, it is primarily all residential and there is indeed a considerable need for a community center not only for the youth but for the adults as well. I handed to you a packet which explains to you the whole procedure. I spent time with the city government of Omaha on this issue for these people and on their behalf. The last action I observed I was told that everything was all right and so I didn't speak to the council. I merely sat silent and watched the action. After that action I was terrible disgusted. That is what prompted me to go to these people and say I will introduce legislation and try to help you on this situation which I think is not very credible on the part of some elected officials. So I am here before you today to ask help for these people and for a community of considerable size, the community which is responsible and have worked diligently in trying to obtain certain facilities for them-If Omaha had annexed SID 95 which they will do no doubt some day, they will not be accummulating a large debt because the community center is estimated to cost about \$1,200,000. Up until the time Omaha annexes them these people will tax themselves to pay off the bonded indebtedness for that center and I think they will do it, no doubt in my mind they will do it. SIDs in some cases are badly managed but in this case this is an SID with exemplary management and exemplary conduct. I am asking to you to accept the amendment of Senator Newell and advance LB 30 to E & R initial. Thank you.

SENATOR CLARK: Senator Haberman. Senator Higgins.

SENATOR HIGGINS: Mr. President, are we speaking to the Newell amendment or to the bill itself? Are we speaking to the Newell amendment or to the bill itself?

SENATOR CLARK: The amendment, the Newell amendment. Do you wish to speak to the bill?

SENATOR HIGGINS: I was going to speak to the bill, not the amendment.

SENATOR CLARK: Thank you. Senator Stoney.

SENATOR STONEY: Mr. President, members of the Legislature, I do have a little reservation in supporting Senator Newell's amendment and I am sympathetic with what Senator Koch is attempting to accomplish for these people in his legislative district but I think that Senator Landis very well articulated the difficulties that we might have in taking a tested and true law, in making an alteration in one case as an exception. Now I would like to ask of Senator Koch if he would respond to a simple question.

SENATOR KOCH: I will.

SENATOR STONEY: Senator Koch, was consideration given since there are extenuating circumstances in this particular case to writing the language in the law to specifically allow this SID to accomplish their purpose?

SENATOR KOCH: Would you repeat that, Senator Stoney? I didn't get it all.

SENATOR STONEY: Senator Koch, the question I am asking is, was consideration given to providing in the language of this bill the SID to accomplish their purpose so that we wouldn't affect in totality the law which I feel is a good one, a right one and a just one?

SENATOR KOCH: Yes, and that is the reason I accept Senator Newell's amendment because it does sunset itself and we are doing this particularly for a very unique SID, Senator Stoney.

SENATOR STONEY: Thank you, Senator Koch. There is only one additional reservation that I have with accepting Senator Newell's amendment, that being should there be other SIDs where the same circumstances do not justify their having the ability to do this, taking advantage of this within the one year time frame that we are establishing with this particular amendment. Perhaps I could visit with both Senators Newell and Koch and more definitive language could be adopted to provide in this particular case these individuals that wish to make this change in the SID and still protect the intent of this particular statute. Thank you.

SENATOR KOCH: Mr. Speaker, may I respond to Senator Stoney?

SPEAKER MARVEL PRESIDING

SPEAKER MARVEL: Go ahead.

SENATOR KOCH: When he believes that other SIDs might immediately grab this opportunity I think that he has to remember one thing, that the jurisdiction of Omaha is considerable. It is a three mile jurisdiction and I want you to remember that the statute language is very clear. That SID if they wanted to plan some other kind of facilities would have to go through a number of hurdles. First of all they have to go through the Public Works Committee. They have to go through the Planning Committee. They have to go through the Parks and Recreation Committee and all that has to be approved. They have to be in sync with the master plan of the county and the city and then they have got to go to the City Council and by resolution the City Council then must approve all this and if you know government, that isn't going to happen over night because there are a considerable number of steps they have to take before they ever get to that final situation. There is also a petition system here. They have got to go to their people and they have got to get a petition which demonstrates that those people are indeed willing to carry out this goal and the last thing they have to do after that after the petition then is they also then must publish in a local newspaper of general circulation, the hearing and the procedures. So all those checks and balances are still there so it is doubtful any other SID would really be able to avail themselves of this privilege particularly when you have a sunset provision so I am hoping that this will solve any problems some of you may have in terms of who might abuse it and who will use it. I ask for the adoption of the Newell amendment and the advancement of LB 130 (sic) to E & R initial.

SPEAKER MARVEL: Senator Landis, do you wish to be recognized?

SENATOR LANDIS: Yes, Mr. Speaker, members of the Legislature, I would like to yield my time and to request to Senator Koch, several of us have been talking and I think there are probably questions about the circumstance that brought this bill about and I think in fairness to the body we really do need to ask Senator Koch the specific background of why this bill is here before us and although he may not want necessarily to lay his cards on the table it is a not uninteresting story and if he would yield I would like to give the rest of my time to him.

SPEAKER MARVEL: Senator Koch.

SENATOR KOCH: Thank you. Senator Landis. The study before I did place before you a complete background of this information but obviously Senator Landis wants me to read it into the record and I will and please bear with me because it is a considerable story of what these people have been trying to accomplish. SID 95 has attempted to put some kind of recreational facility for over ten years in that particular area and they are financially able to do this and are responsible enough to afford it. First of all, they were going to build a pool. They were advised the pool probably was in the best interests of the Omaha area, particularly that southwest area and so then they decided they would approach the city on a community center. That is where it all began. So they did approach the city in 1978 and the city said yes. This sounds good. You appear to be financially responsible. Proceed. So then they went forward and conforming with the master plans with the planning division of Omaha, with the Public Works Committee, with the Parks and Recreation Committee, they met all the standards without exception. As I told you earlier they even increased their own mill levy up to almost four mills. That is how serious they were. then armed with the full support of the city's Park and Recreation Department and other agencies they proceeded forward. They went to the city and the vote was six to Yes, the city council said we believe this is a good facility and it certainly will benefit a considerable number of people. So then the resolution went to the mayor. The mayor then proceeded to without discussion with those people or without particular reasons. veto it. So later they went back to the city council. number of city council members said, yes, we agree, you have been good faith and will be good faith. We will override the mayor. Well they proceeded to override the mayor and finally got four votes when I was sure they had five because I was also in this issue by then and so here they sit with four. It takes five to override. city then talked of annexation. This was now in 1980 in July. The mayor was quoted in the local newspaper that he would not veto the SID 95 community center if the council again passed it because annexations have been definitely delayed and none were in near future planned for. So one councilmember then said yes, he had voted against it but now he would change his position. I am not identifying names at all but this is accurate. It is on the record. So again they went back in full faith to the city one more time, didn't get the approval. That is where we are today. We are here and we are saying to you we believe these people do have a special need and have demonstrated everything

in good faith and again I am not here to indict elected officials but I do believe the credibility should be a little better when you are dealing with people in good faith when they have met all of the tests and they have met all the tests. I want you also to know that the Board of Trustees of the SID are homeowners. elected by their own constituents and they serve diligently and so presently they are sitting there waiting to see Whether or not this body will help them. I told the committee in my closing remarks, certainly I have some concern about the rights of mayors and the legislative bodies and the courts preserve their sovereignity but we really are the mayor when it gets down to the final issue because the Legislature created SIDs and we as a body can make certain determinations if we feel that there is indeed a demonstrated need to help them on certain occasions and I have no fear that other SIDs will abuse this particular privilege. It really pertains to SID 95 by and large. Thank you.

SPEAKER MARVEL: Senator Higgins.

SENATOR HIGGINS: Mr. President and fellow Senators, I just want to bring out the fact that people in this SID do not live in the City of Omaha. They had nothing to do with the election of our mayor or our city council and I think that inasmuch as they are under the government of our mayor and our city council, since they don't have the power to vote them in or out of office or to even help themselves, that I would urge you to vote for Senator Koch's bill just in all sense of honesty and decency to these people. Thank you.

SPEAKER MARVEL: Senator Haberman, we are speaking to the Newell amendment.

SENATOR HABERMAN: Mr. President, members of the Legislature, speaking to the amendment, I wholeheartedly endorse the amendment and the bill because I was just aghast at some of the things that happened to these people when they tried to get their SID through the City Council of Omaha and the only thing I can say is that the Mayor of Omaha can be glad he is the Mayor of Omaha and not out in our part of the country because we wouldn't stand for things like this so I would wholeheartedly endorse the amendment and the bill. Thank you.

SPEAKER MARVEL: Senator Newell, do you have any other comments on your amendment? Do you want to close?

SENATOR NEWELL: Well I would just like to keep it in perspective. This is a one year sunset provision. Without this

I think the bill would be not only a bad principle but it would be a terrible travesty. Thank you.

SPEAKER MARVEL: The motion is the adoption of the Newell amendment to LB 30. All those in favor vote aye, opposed yote no. Record the vote.

CLERK: 28 ayes, 0 nays, Mr. President.

SPEAKER MARVEL: The motion is carried. The amendment is adopted.

CLERK: I have nothing further on the bill, Mr. President.

SENATOR KOCH: Mr. Speaker and members of the body, on behalf of those citizens of SID 95 I thank you. I ask to advance LB 30 as amended to E & R initial.

SPEAKER MARVEL: Senator Remmers, your light was on.

SENATOR REMMERS: Mr. President and members of this body, I want to speak in support of Senator Koch's bill. It is true this might be special legislation but I think SIDs were special legislation and I don't think the law is always fair. I think that these people are put in a position where they are, you might say, captives. They have advanced in good faith and I don't think they have been dealt with in good faith and I think there are times when we do have to make some exceptions and I believe this is a time when that exception is in order and I urge you to support Senator Koch's bill.

SPEAKER MARVEL: Senator Dworak, we are speaking to the bill as a whole.

SENATOR DWORAK: Mr. President and colleagues, we do have one SID in Platte County so I guess I can speak on it although we don't quite have the problem that they have in Omaha but I am a little concerned philosophically about taking the executive out of the decision making process. That is an important facet of government and I might even be able to be a little more comfortable with this bill if the current members of the Omaha City Council were elected by district but since they are not and since approximately four of them live within an eight block area it seems to me by taking the executive out also we are totally disenfranchising about 90% of the people in the City of Omaha in this area. So I think that this is on a basic, broad good government philosophy is a poor bill and a poor precedent to establish. I think any member from a small district has a different perspective on government just like each one of us have a different perspective from the interest of our

legislative district than the Governor has. So I think this is an attempt to put in a piece of poor government generally. I think it is a bad precedent. I think it is a bad bill and I think this bill should stop right here.

SPEAKER MARVEL: Senator Newell, do you want to speak to the bill as a whole?

SENATOR NEWELL: No, thank you.

SPEAKER MARVEL: Okay, the motion before the House is the advancement of LB 30 as amended. All those in favor of advancement of the bill vote aye, opposed no. Have you all voted? The motion is the advancement of the bill. Record.

CLERK: 25 ayes, 5 mays on the motion to advance the bill, Mr. President.

SPEAKER MARVEL: The motion is carried. The bill is advanced. The next bill, LB 130.

CLERK: Mr. President, LB 130 was offered by the Administrative Rules and Regulations Committee and signed by its members. (Read title.) The bill was first read on January 13 of this year. It was referred to the Administrative Rules for public hearing. There are committee amendments pending by that committee, Mr. President.

SPEAKER MARVEL: Senator Johnson.
