reviewing the committee amendments, it gives the defendant a right to appeal to the Supreme Court a ruling on say his motion to suppress evidence if it is unsuccessful from the defendant's point of view. Now if we have a backlog of 14 months, let's say, in the Nebraska Supreme Court, and I understand that backlog is increasing because there are more appeals filed than there are cases decided every month, what would prevent a defendant from using that as a delaying tactic? In other words, filing a motion to suppress evidence, a confession or physical evidence of some sort, having that denied by the court then taking an appeal to the Nebraska Supreme Court and that way having his criminal trial delayed for 14 months while the Nebraska Supreme Court handles that?

SENATOR SIECK: I am going to refer that question to Senator Nichol, because I think he can more capably answer it.

SENATOR NICHOL: Well, Mr. Chairman, I would just say this, whenever you ask for an appeal you take your chance on whether you will get a speedy trial or not. If you don't want to ask for an appeal, why you can have it now. If you do, you may risk the chance of having a speedy trial, that's true.

SENATOR HOAGLAND: Yes. But I mean...I don't want to take a lot of time, but in most situations the defendant is not locked up pending trial, so it's in his interest just to delay the thing as long as possible hoping a witness will move out of town or will pass away or something. Well, we can talk about this on Select File, perhaps.

SPEAKER MARVEL PRESIDING

SPFAKER MARVEL: The motion is to advance the bill. All in favor of advancing 411 to E & R for Review vote aye, opposed vote no. Have you all voted? Have you all voted? Record.

CLERK: 25 ayes, 0 nays on the motion to advance the bill, Mr. President.

SENATOR WESELY: Mr. Speaker and members of the Legislature,

the Public Works Committee did hear this bill and we are concerned a bit about the suspension of drivers' license. So we have the committee amendments which are before you and I move their adoption to try and clarify some concerns that we had. First off, we changed it so that we are only dealing with the suspension of a license for somebody who under this compact in another state who is under the compact violates the traffic laws and then they don't pay their fine or don't go to court or whatever and they come back to Nebraska. We specify that is the only case we are talking about. We don't suspend their license within the State of Nebraska, we take that part out because there is a process that they already have to go through that. We deal only with the question of somebody out of the state violating the law and then not complying with court appearances in coming back to Nebraska. So we give them 30 days notice that they have to appear in court or pay their fine, or whatever, and if they don't they get their license suspended. We put that into the bill in the committee amendments, and then if that is not observed then we can go ahead and suspend the license but we also say in the committee amendments that that can only be until they then meet with the law and either go to court or pay their fine, or whatever they are supposed to do, and then they get their license back. So we make it much clearer as to the suspension of license and I think it is a better way because we protect the individual but still have that threat over them so that they will make sure that they meet the law. We also add the E clause and I want to emphasize that we are talking about the corrected committee amendments which are on page 1388. That is the committee amendments and I am now moving their adoption.

SPEAKER MARVEL: The motion is the adoption of the committee amendments as explained by Senator Wesely. All those in favor vote aye, opposed vote no. We're voting on the adoption of the committee amendments. Have you all voted? Record.

CLERK: 25 ayes, 0 nays on adoption of the committee amendments, Mr. President.

SPEAKER MARVEL: The motion is carried. The committee amendments are adopted. Senator Landis.

SENATOR LANDIS: I just wanted to describe the provisions of the bill and then move its adoption to E & R Initial. Mr. Speaker, the nonresident violator compact is a model national bill that is agreed to presently by 20 jurisdictions, and there are apparently about 9 other states that are considering its adoption at this time, Nebraska being one of them. Currently if you pass through Nebraska and live in

another state, you are stopped for a speeding violation, the highway patrolman accompanies you to the county seat where you file a bond, or you make your court appearance, and then the county...the highway patrolman either hears the case or sometimes has to do some paper work additionally at a later date. What this allows for is an individual to be given a ticket, a citation at that location, and then they may go on their way and they may go home to their home state and then they may file that same kind of waiver that we do now for tickets and pay their fines while living in their home state, having returned home from their trip. And if they fail to pay the assessed fine, then that state, if it is a member of this compact, will go out and pick up the license of the person for failing to respond to the Nebraska citation. We also then promise for Nebraska drivers who are picked up in other compact states who refuse to honor those tickets that we will pick up their licenses here in this state. The highway patrol supports this. It is one of the Governor's Task Force recommendations. So far attempts have been made to identify the cost savings. It will keep troopers on the highway in the business of law enforcement rather than taxing out of state drivers to a county seat for processing and I believe the figure that has been arrived at as far as savings is roughly \$120,000. Now that means that manpower will be able to be utilized in other ways, more profitable ways than simply taxing people back and forth and filling out paper work. Also there will be some driving that will not have to be done and that can be used in law enforcement rather than this taxing back and forth that is being done now. Hopefully, it will decrease the number of failure to appears, it will increase court revenue since nonresidents will not ignore our state's tickets and citations, and lastly, highway enforcers...highway law enforcement enforcers, rather, will be able to devote more time to highway patrol safety, apprehension and surveillance rather than dealing with non-resident violators and taking them into the county seats. Most of our surrounding states are members so that we have a high potential of utilizing this act...Iowa, South Dakota, Missouri, those are all members of the compact and we can expect to utilize this in conjunction with drivers from those states. I would move its adoption and I would hope it will be sent on to Select File.

SPEAKER MARVEL: The motion is the advancement of the bill to E & R for Review. All those in favor...we're talking about LB 344, all those in favor of advancing that bill vote aye, opposed vote no. Record the vote.
