I am asking that the body advanced LB 317 to E & R Initial as amended.

SPEAKER MARVEL: The motion is to advance the bill to E & R Initial. All those in favor vote aye, opposed vote no. Record the vote.

CLERK: 27 ayes, 0 mays on the motion to advance the bill, Mr. President.

SPEAKER MARVEL: The motion carried. The bill is advanced.

## RECESS

SPEAKER MARVEL PRESIDING

SPEAKER MARVEL: Record your presence please. We need four more votes to start the process and I would remind you that this is the last full day before half days so we have got a lot of work to do. Record.

CLERK: There is a quorum present, Mr. President.

SPEAKER MARVEL: Do you have some items to read in, Pat?

CLERK: Mr. President, I have two reports from a couple of different Natural Resource Districts regarding payment of attorney fees during the past interim.

Mr. President, Senator Howard Peterson would like to add his name to LB 798 as cointroducer. That is all I have.

SPEAKER MARVEL: Okay, the next order of business is what? The first item of business is LB 450.

CLERK: Mr President, LB 450 offered by the Performance Review and Audit Committee. (Title read.) The bill was first read on January 20 of last year, referred to the Public Health and Welfare Committee for hearing. It was advanced to General File with committee amendments attached, Mr. President.

SPEAKER MARVEL: Senator Cullan.

SENATOR CULLAN: Mr. President, members of the Legislature, this is again the same discussion that was initiated before we recessed this morning. So far the committee amendments address the same three issues that we addressed earlier in the bills related to the Bureau of Examining Boards and the bill related for medicine and surgery and the regulatory agency for optometry. This bill only relates to podiatry but the issues again are whether to eliminate the testing requirement for continuing education courses, to delete the promulgation of sanitary rules and regulation and inspection of podiatrists offices, and, thirdly, to delete the requirement to file all alleged statutory violations with the Attorney General. I will again assume that Senator Warner has the same amendment on the desk to make the committee amendments consistent with the other regulatory programs that we enacted or advanced earlier this morning. I will again support Senator Warner's amendment.

SPEAKER MARVEL: The Chair recognizes Senator Warner.

SENATOR WARNER: Mr. President, I move adoption of the amendment. Again this is reinstating the section that requires statutory violations to be reported to the Attorney General to make a determination as to whether or not what appropriate action should be made. I move its adoption.

SPEAKER MARVEL: The first order of business is to vote on the Warner amendment as explained by Senator Warner and we are talking about LB 450. All in favor of the adoption of the Warner amendments vote aye, opposed vote no. This is in your General File folder, six down. Have you all voted? Record.

CLERK: 28 ayes, 0 mays on the adoption of Senator Warner's amendment.

SPEAKER MARVEL: Motion is carried. Senator Warner's amendment is adopted. Now we are ready to adopt the committee amendments as amended. Senator Warner, do you want to do that.

SENATOR WARNER: I don't want to. Senator Cullan wants to.

SPEAKER MARVEL: Okay, Senator Cullan.

SENATOR CULLAN: I move to adopt the committee amendments.

SPEAKER MARVEL: The motion is the adoption of the committee amendments as amended. Is there any further discussion? All those in favor vote aye, opposed vote no. Have you all voted? Have you all voted? Senator Cullan, what is your pleasure?

SENATOR CULLAN: Mr. President, I would ask for a Call of the House or six more votes.

SPEAKER MARVEL: Shall the House go under Call? All those in favor of that motion vote aye, opposed vote no. Record the vote.

CLERK: 26 ayes, 1 may, Mr. President, to go under Call.

SPEAKER MARVEL: The Legislature is under Call. All legislators please take your seats. Unauthorized personnel please leave the floor and record your presence. The Chair will authorize call in votes. Senator Rumery.

CLERK: Senator Higgins voting yes. Senator Rumery voting

yes. Senator Wagner voting yes. Senator Beyer voting yes. Senator Vickers voting yes. Senator Wiitala voting yes. Senator Duda voting yes.

SPEAKER MARVEL: Record the vote.

CLERK: 26 ayes, 7 nays, Mr. President, on the adoption of the committee amendments.

SPEAKER MARVEL: The motion is carried. The committee amendment is adopted. Senator Cullan, do you wish to explain the bill? Senator Warner, sorry.

SENATOR WARNER: Mr. President, I move LB 450 be advanced. This is the one on the Board of Examiners of Podiatry and again it has the same comparable provisions of the other two bills in that the attendance of the board is only present for examinations involving practical work, that the fees are adjusted to reflect the range, and the specific fee set by the board to reflect the administrative cost. A statement of purposes is included now minus the protection of the public in making sure that the facility has ample health inspections. Then the bill also has the provisions relative to adopting requiring them to have rules and regulations defining conflict of interest and it, of course, strikes the termination date as in the law for sunset, and the emergency clause, the same proceedings as the other two bills. I move it be advanced.

SPEAKER MARVEL: The motion before the House is the adoption of the amendments to LB 450. The motion is to advance. All those in favor vote aye, opposed vote no. Record the vote.

CLERK: 32 ayes, 0 mays on the motion to advance the bill, Mr. President.

SPEAKER MARVEL: Motion carried. The bill is advanced. Next bill is 263.

CLERK: Mr. President, LB 263 offered by the Public Health Committee. (Title read.) The bill was read on January 16 of last year, referred to the Public Health Committee for hearing. The bill was advanced to General File. Mr. President, there are committee amendments pending.

SPEAKER MARVEL: The Chair recognizes Senator Cullan to speak to the committee amendments in regard to LB 263.

SENATOR CULLAN: Mr. President, members of the Legislature,

SENATOR CLARK: Senator Wesely, do you want the committee amendments?

SENATOR WESELY: Yes, Mr. President, members of the Legislature. this bill was referred to the Public Health Committee, was heard last year and there was a concern at that time about the fact that it applied only to Dental Review Committee and the feeling was that by just limiting it to the Dental Review Committee there might be some special legislation constitutionality problems and so we thought that the concept was worthy of application across the board to all peer review committees and so the committee amendment would strike the fact that this is specifically dealing with the Dental Review Committee and make it applicable to all Nebraska peer review committees and again the concept is this in LB 267 that proceedings before a peer review committee would still take place and function as they have before. The question comes when court action is taken and some action is taken before a dentist or anybody associated with a peer review committee. They cannot then go to the committee records and use the committee action against the person or for the person for that matter who is being brought to court and being contested in court. So that you could still use materials and all that that would be brought before this peer review committee but the actual work of the committee would be kept out of the court process and decided that would be separated from the court action. That is what we are trying to do and we thought if it was applicable to dentists it ought to be applicable to others. So that is what the committee amendment does, Mr. President.
