Senator Schmit, I have to close wiin this, you mentioned surplus of teachers. You had better look at the record today. There is not a surplus, only in a very few fields. In fact, there are shortages developing and by mid 1980's there are going to be very severe shortages for a number of reasons, and the Education Committee does not control the number of people who matriculate in a standing college. That is only controlled by the Regents and you know that. If you want to talk about surpluses, my figures show there are eight hundred and some veterinarians in this state and the veterinarians tell me that is a surplus. So let's get down to the issue. Is it Education or isn't it, and I request that the bill be rereferenced to the Education Committee. Thank you.

CLERK: Mr. President, the motion is that LB 245 be rereferred from the Agriculture and Environment Committee to the Education Committee.

SPEAKER MARVEL: All those in favor of that motion vote aye, opposed vote no. Call the roll, Mr. Clerk.

CLERK: (Roll call vote taken as found on page 287 of the Legislative Journal.)

SPEAKER MARVEL: Legislators, you are still supposed to be in your seats. The Clerk did not announce the vote.

CLERK: 19 ayes, 26 nays, Mr. President, on the motion.

Your committee on Public Works whose Chairman is Senator Kremer reports LB 230 to General File with amendments; and LB 511 to General File with amendments. Signed Senator Kremer as Chair.

I have a series of resolutions ready for your signature, Mr. President, LRs 26, 28, 30, 31, 32, 35, 36, 37, 38, and 39.

SENATOR REMMERS: Mr. Speaker, members of the body, I would like to just make a few comments. I am a little bit reluctant because you might say it is sort of a special interest bill but I will assure you it is not going to affect my pension very much but I do think that we need to make some adjustments in teacher retirement benefits. I think first if we look at comparison with other states, I believe of the entire midwest, we rank at the bottom, and when on top of that you add the fact we probably rank about 35th in salaries, and Nebraska is not a poor state. I believe generally we rank somewhere in the middle or above average on personal income so we are not a poor state. I think we can afford to pay the teachers and I think they are entitled to a better retirement figure than they have. As a superintendent of a small school, I know I have seen many young men that have been in the teaching profession for a few years and the good ones don't stay very long. They drop out because there isn't any future and I think currently with the lid that we have had the last couple of years I think we need to do something to encourage people to get into the education business, to become teachers. They have become very discouraged the last couple of years with the future for Nebraska and I don't think we can afford to do I think we owe our children better than that and I would encourage you to support this bill. I think we still will not rank very high as far as teacher benefits are concerned. I think this is a very modest improvement and I would urge you to support it.

SPEAKER MARVEL: The motion is the advancement of LB 248 as explained. Senator Wiitala, do you wish to close?

SENATOR WIITALA: Mr. Speaker, I would just move to advance LB 248.

SPEAKER MARVEL: All in favor of that motion vote aye, opposed vote no. Record.

CLERK: 25 ayes, 1 may on the motion to advance the bill, Mr. President.

SPEAKER MARVEL: The motion is carried. The bill is advanced. Next bill, 463.

CLERK: Mr. President, LB 463 (Read title). The bill was read on Janury 20, referred to Retirement. It was advanced to General File. I do have committee amendments pending, Mr. President.

SPEAKER MARVEL: Senator Fowler.

LB 463, 381

SENATOR FOWLER: LB 463 is a simple bill. It says that people who work beyond the normal retirement age should be able to contribute to a retirement plan up to the age they choose to retire or are required to retire. The bill was introduced to provide uniformity in this area for all retirement systems but a question was raised with regards to the area of public safety, that is, police and fire service, and it was felt that in fact this principle we may not want to extend as broadly to police and fire as we do other areas so the committee adopted an amendment that remove police and fire from this of the primary cities and the first class cities and leave the law as is in those areas. I would move for adoption of that amendment.

SPEAKER MARVEL: The motion is the adoption of the amendment as explained by Senator Fowler. All those in favor vote ave. opposed vote no. Have you all voted? Record.

CLERK: 26 ayes,0 nays on adoption of the committee amendments, Mr. President.

SPEAKER MARVEL: The motion is carried. The committee amendment is adopted. Senator Fowler.

SENATOR FOWLER: Mr. Chairman, I would move that the bill be advanced. As I indicated it simply establishes for all the remaining retirement systems the principle that if you work beyond age 65 to say age 70, you work beyond the normal retirement age, you should be able to contribute, continue to contribute to a retirement plan, and then when you retire, the benefits would reflect that contribution. So I would move advancement of LB 463.
