PRESIDENT: The Legislature will come to order and register your presence.

CLERK: Mr. President, Senator Higgins and Beutler would like to be excused this afternoon.

PRESIDENT: Record the presence, Mr. Clerk.

CLERK: There is a quorum present, Mr. President.

PRESIDENT: Quorum being present, do you have any messages on the desk, anything to read into the record?

more filings to recover on debt when we see the economy in the state that it is today. The filing of a transcript involves a similar procedure with the Clerk of the District Court as is required in the filing of a new case in their office. The only exception being is that there is less paperwork involved here than there would be in an original filing. The cost of an original filing is \$35 and the Clerks of the District Courts felt that the increase to \$25 would be sufficient to handle the cost of the increased volume of cases that they are seeing in these filings. So I would move that LB 84 be advanced from General File to E & R Initial.

SPEAKER MARVEL: The motion is to advance the bill to E & R for review. All those in favor vote aye, opposed vote no. Record the vote.

CLERK: 27 ayes, 0 nays on the motion to advance the bill, Mr. President.

SPEAKER MARVEL: The motion is carried. The bill is advanced. The reason that we pause for a minute is that we are trying to find some bills that members who are here now are ready to take up. Senator Rumery, are you ready to take up LB 47?

SENATOR RUMERY: Yes, Mr. President.

CLERK: Mr. President, LB 47 was a bill introduced by Senator Myron Rumery. (Read title.) The bill was read on January 8, referred to the Public Works Committee. The bill was advanced to General File. There are committee amendments pending by the Public Works Committee, Mr. President.

SPEAKER MARVEL: Senator Kremer. It is LB 47.

SENATOR KREMER: Mr. Chairman, it caught me kind of off guard but I think what we do here is we add the emergency clause and make a couple of technical changes. Inserts a new section, Section 5, and adds the emergency clause.

CLERK: No, sir.

SENATOR KREMER: Oh, 47?

CLERK: Yes, sir, 47. It should be in your bill book, Senator.

SENATOR KREMER: Oh, yes, thank you. I got a hold of the wrong bill. Okay, the committee amendments clarifies which tenants can give permission to park and can request that a vehicle...to give a law enforcement officer the discretionary

powers to remove the vehicle. We are talking about illegal parking in a designated parking lot, Senator Rumery, is that not right? We are talking about parking lots, private parking lots, and #2, I guess #2 gives certain authority to the enforcement officer. #3, it defines what we mean by law enforcement officer so as to allow the use of civilian parking enforcement personnel. They also can have the authority to remove this vehicle. Also to strike Section 2 of the bill which changes the sign requirements as to specify what kind of a sign has to be there with respect to who can park there and who cannot park. I move the adoption of the committee amendments.

SPEAKER MARVEL: The motion is the adoption of the committee.. ..okay, first we take up Senator Rumery's amendment to the committee amendments and then adopt the committee amendments.

CLERK: Mr. President, Senator Rumery moves to amend the committee amendments and his amendment is on page 807 of the Journal. (Read.) It is found on page 807 of the Journal. 807, Senator.

SENATOR RUMERY: Mr. President, members of the Legislature, the Clerk pointed out the amendment is on page 807 in the Journal and I move the amendment.

SPEAKER MARVEL: Senator Newell, do you want to speak to the Rumery amendment? Your light is on.

SENATOR NEWELL: Yes, I do, and I need to get to 807. Senator Rumery, maybe if I could ask, while I am looking at the amendment that you are offering, basically, to outline what the intent of the bill is. The reason I ask this is that this has been a ticklish issue especially in my area of the state for a long time and I offered legislation on this a few years back and I am curious how you are amending it and so forth. So if you could do that while I am looking at 807, I would appreciate it.

SENATOR RUMERY: This has been a problem in our area, also. People just blatantly have been moving in on private parking lots and parking vehicles there for sometimes hours at a time, absolutely paying no attention to the parking facilities and its use. So we would like to have this so that the owner of the parking lot can have some protection on it. You may say, well, we already have protection. They can tow the vehicles away and you and I know what has happened on some of those occasions when the towing vehicle has damaged a car or a pickup and it is a big hassle then. The main thing we would like to do here

now is to after the parking lot is clearly identified that the police would have the authority to come in and write a citation just like they would for overparking on the street or any other infraction that they might enter into and we would like to have it so the owner of the lot can simply call the police and say, "Well, I have a vehicle here who is overparked", and we would like to use this traffic violation largely in place of the towing although we are not completely eliminating the towing of the vehicle. But these parking lot owners really need some protection and I think you would agree to that.

SENATOR NEWELL: Senator Rumery, just for your information in regard to this, the police in the City of Omaha are not anxious to have this authority. In fact, two years ago they asked me to delete the responsibility for the police officer to make a decision as to whether an automobile ought to be towed or not and even in the ticket writing area, especially in the private lots, that their reasoning was simply this, that the question of authority is a difficult one to know who really can authorize, and the question of how well the lot is posted always gets to be a problem, and who can indicate whether, you know, in your amendment you are offering tenant and landlord can suggest that it is parked illegally. That has created numerous problems and a lot of difficulty in our area of the state and is something that they were not anxious to have that authority, and I am wondering if there might be some way we can work this out to where we....

SENATOR RUMERY: Well, we would be glad to listen, of course, to anything that might be reasonable on this procedure. But we think that this has some advantage over just towing them away and we mentioned awhile ago the hazards of pulling somebody else's car away and this sort of thing but the parking lot owners need protection and this is the best thing that we could come up with that we thought would help in that respect and I don't know, I can't imagine why they are opposed to it. Every private parking lot that has mentioned anything to me wants this kind of protection and....

SENATOR NEWELL: Well, the Omaha City Police have a problem with being the ones to enforce private parking lot situations. With the towing away which just is what is required now, there is not...it is more clearly the individual who owns the place charging the towing to be taking place and that alleviates the police from a whole lot of questions about who has the responsibility, the rights, et cetera, and there in lies the problem. Let me ask you another question related to that. In terms of your amendment, you are striking

#1 and #2 of the committee amendments. Now what does that do exactly? You are striking #2 and #3. It said, "Strike committee amendments #2 and #3. On page 3, line 4, after 'lot' insert 'state the hours of restricted parking and state who to contact for information regarding towed vehicle.'"

SENATOR RUMERY: We are simply trying to make it simple so that the owner can call the police. Now you mentioned the private parking lot. Do we not have the authority to call the police in case somebody is trespassing on our property? Our own property?

SENATOR NEWELL: Yes, but therein lies the complaint arrangement where you have to file a complaint and indicate, you know, and set charges. So that, in fact, is also a crime against property by a person as opposed to be a vehicle which is (interruption).

SENATOR RUMERY: But a person left the vehicle there and the vehicle isn't being fined, it is the person that we hope would be.

SENATOR NEWELL: Senator Rumery, let me just make a suggestion. I would not oppose the advancement, the adoption of your amendment and the advancement of the bill but I would, if it would be okay, like to sit down with you and discuss both your desire and get back to the City of Omaha Police Department and find out just exactly how they view this.

SENATOR RUMERY: We can look at it again on Select File.

SENATOR NEWELL: That is what I was suggesting.

SENATOR RUMERY: Thank you.

SPEAKER MARVEL: Okay, your motion now is the adoption...

SENATOR RUMERY: Of the amendment.

SPEAKER MARVEL: ...of your amendment of the committee amendments, is that it?

SENATOR RUMERY: Right. I so move.

SPEAKER MARVEL: All those in favor of that motion vote aye, opposed vote no. We are voting on the Rumery amendments to the committee amendments to LB 47. Have you all voted? Okay, record.

There will be a signing of a proclamation in the rotunda and the members of the Legislature are invited. The celebration begins around eleven-thirty and I assume those of you who want can check on the rotunda. Meanwhile we will continue with LR 26.

CLERK: Mr. President, LR 26 is found on page 673 of the Journal. It is offered by the Public Works Committee and signed by its members. (Read.)

SPEAKER MARVEL: Senator Kremer.

SENATOR KREMER: Mr. Chairman and members of the Legislature, LR 26 was brought to the Public Works Committee by some of the subdivisions of government in the southwestern part of the state, namely tri-county interests and some of the NRDS in that area of the state. The resolution was signed by a number of the members of the Public Works Committee and then was held up for several days in order to learn if we could, how this project would be of benefit to Nebraska and if there were any disadvantages, what they would be. You have heard the resolution read and I have had the Pages lay a map on your desk, on each one of your desks, to show you where this proposed project is as related to Nebraska. You will note on the map that the dam would be close to Ft. Morgan, Colorado, and it would provide irrigation waters on and along the South Platte River almost to or to the Nebraska state line. Now I am trying to explain to you what the advantage would be to the State of Nebraska. I would like to make five important points why I think Nebraska should support this resolution. Some ask the question, why should Nebraska get involved in a project that is not in the state itself and it is a good question and I will try to answer that as I make these several points. First of all, if Nebraska does take a positive action on the

SPEAKER MARVEL: Shall the House go under Call? All those in favor vote aye, opposed no. Okay, record.

CLERK: 17 ayes, 11 nays to go under Call, Mr. President.

SPEAKER MARVEL: The House is under Call. All legislators please take your seats. Record your presence. Senator Beutler, Senator Newell, Senator Schmit, Senator Hoagland. Mr. Sergeant at Arms, will you see if you can find Senator Schmit, please?

CLERK: Mr. President, while we are waiting for Senator Schmit, I have an Attorney General's Opinion that is addressed to Senator Carsten and one addressed to Senator Haberman. (See pages 1247 through 1252 of the Legislative Journal.) Senator Pirsch would like to print amendments to LB 17, and Senator Landis and Howard Peterson to LB 478, and your Enrolling Clerk respectfully reports that she has presented to the Governor for his approval the following bills: 47, 84, 151, 220, and 313.) And your Committee on Enrollment and Review respectfully report that they have carefully examined and engrossed LB 245 and find the same correctly engrossed, and 245A correctly engrossed.
