Finally, Mr. President, I have a proposed rule change offered by Senator Newell. That will be referred to the Rules Committee for their consideration.

PRESIDENT: Before we go on to the next point the Chair takes pleasure in welcoming back to the Legislature former Senator and Mrs. Murphy, Bob and Bess, you are under the north balcony. Bob and Bess would you stand out here and be recognized and welcome back.

Senator Koch, for what purpose do you rise?
