LB 563-566, 592, 664

SENATOR LAMB: Yes, Mr. President.

PRESIDENT: The Chairman recognizes Senator Lamb.

SENATOR LAMB: Mr. President, members of the Legislature, I would move to advance five bills directly to General File, LB 563, LB 564, LB 565, LB 566 and LB 592. These bills, I will describe each one of them...

PRESIDENT: A motion then, Senator Lamb, is to suspend the rules first. That is your first motion then is to suspend the rules and we'll take that up and then we will proceed from there. Any discussion on the motion to suspend the rules?

SENATOR LAMB: Could I add 664 to it? I do not have that on my list.

PRESIDENT: Yes. Now we will take a separate vote on each bill so we will take them up one by one. All right, if there is no further discussion, Senator Lamb, we will take a vote on all of them for purposes of suspension and then we will take them up individually for the attention to each bill. All right, the motion then before the House is suspension of the rules to take up these six bills. All those in favor vote aye, opposed nay. This will require 30 votes. Have you all voted on the motion to suspend the rules to take up these bills, revisors bills and one other, six bills, agenda item #6 if you want to refer to the bills. Have you voted? Senator Lamb, I guess maybe the only way we are going to get these people in here to vote is to have a Call of the House if they don't come in pretty soon. You really need one more vote, huh? Record the vote.

CLERK: 31 ayes, 0 nays, Mr. President, on the motion to suspend the rules.

PRESIDENT: The motion carries. The rules are suspended. The Chair recognizes Senator Lamb.

SENATOR LAMB: The first bill is LB 563 which is recommended by the bill drafter that this be reported directly to General File. LB 272 passed in 1981 adopted a new limited partnership act. The act became operative January 1, 1982. Existing partnerships have until January 1, 1983, to file with the Secretary of State to continue their existence. The change of the date in LB 563 merely harmonizes the first sentence of this section with the second sentence of the section and provides what law is to apply to the partnership that were in existence on January 1, 1982.

LB 566, 592, 664

SENATOR LAMB: Mr. President, I move LB 566 be advanced to E & R initial. LB 249 in 1981 put the Department of Health under the direct control of the Governor rather than under the State Board of Health. The revisors statutes was to substitute "Department of Health" for "State Board of Health" where such term appeared in the statutes. Some of these changes did not fit or make sense so the bill shows some additional changes.

PRESIDENT: Any discussion on the advancement of LB 566? The question then before the House is the advancement of LB 566 to E & R initial. All those in favor vote aye, opposed nay. Record the vote.

CLERK: 27 ayes, 0 nays on the motion to advance LB 566, Mr. President.

PRESIDENT: Motion carries and LB 566 is advanced to E & R initial. LB 592. Senator Lamb.

SENATOR LAMB: Mr. President, I move that LB 592 be advanced to E & R initial. In 1980 this body passed a bill which requires the revisor's statute to ferret out the obsolete statutes so that this body can delete them from the statutes. This bill contains those obsolete statutes and I move that it be advanced.

PRESIDENT: Any further discussion on LB 592? Hearing none, the question before the House is the advancement of LB 592 to E & R initial. All those in favor vote aye, opposed nay. Have you all voted? Record the vote.

CLERK: 25 ayes, 0 nays, Mr. President, on the motion to advance the bill.

PRESIDENT: The motion carries and LB 592 is advanced to E & R initial. Senator Lamb, are you going to take LB 664, too? LB 664. The Chair recognizes Senator Lamb.

SENATOR LAMB: Mr. President, I move that LB 664 be advanced to E & R initial. This is a bill that was brought to the Reference Committee by Senator Vard Johnson. It's a bill which would name a gymnasium over at the Nebraska School for the Deaf after Mr. Nick Peterson. The people over there would like to have this done immediately because they would like to honor Mr. Peterson on January 16 and I believe it is a noncontroversial bill. I would ask that it be advanced.

PRESIDENT: Any discussion on LB 664? Hearing none, the question before the House then is the advancement of LB 664 to E & R initial. All those in favor vote aye, opposed nay.

SPEAKER MARVEL: The next bill is LB 226.

CLERK: Mr. President, I have a request from Senator Haberman to pass over LB 226.

SPEAKER MARVEL: The motion is to pass over 226. Is there any objection? If not, so ordered. What about 226A?

CLERK: Same, pass over 226A, Mr. President.

SPEAKER MARVEL: The motion also includes passing over 226A. Is there any objection? So ordered. The next item of business, LB 454.

CLERK: Mr. President, LB 454 offered by Senator Carsten. (Read title). The bill was read on January 20 of last year.

SENATOR CLARK: Senator Wagner.

SENATOR WAGNER: Mr. Speaker and members, I had a concern about the Warner amendment that was passed around here a day or so ago and this related to any of the mailings, particularly bulk mailings might have this notice in there. So working with Senator Warner, this has been cleared up and essentially what it says is that any mailing that has this election notice in there will be sent first class mail so I think it is a must and I think the amendment takes care of it and I certainly support the amendment.

SENATOR CLARK: Senator Warner, do you wish to close? No closing. The question before the House is the adoption of the Warner amendment. All those in favor vote aye, opposed vote nay.

CLERK: Senator Clark voting yes.

SENATOR CLARK: Have you all voted on the Warner amendment? Record the vote.

CLERK: 26 ayes, and 1 almost aye, Mr. President, on the motion to adopt Senator Warner's amendment.

SENATOR CLARK: We will call that 26½. The amendment is adopted. Is there any further amendments?

CLERK: I have nothing further on the bill, Mr. President.

SENATOR LAMB: Mr. President, members, I do have an amendment to LB 592 which merely strikes the statutes which deal with

the Bicentennial Commission. According to the statute, that Bicentennial Commission exists until June 30th, 1984, and while it may be in order to remove that from the statutes at this point, I don't think it should be done under the obsolete statutes provisions. Somebody could object and, in fact, they have objected and so I would ask that those sections which I have indicated in that amendment be stricken from the bill.

SENATOR CLARK: Senator Lamb. Is there any further discussion on the Lamb amendment? If not, all those in favor vote aye, opposed vote nay.

CLERK: Senator Clark voting yes.

SENATOR CLARK: Have you all voted? Record the vote.

CLERK: 25 ayes, 0 nays, Mr. President, on the adoption of Senator Lamb's amendment.

SENATOR CLARK: The amendment is adopted. Further amendments.

CLERK: Senator Hoagland would move to amend.

SENATOR CLARK: Senator Hoagland is not here.

CLERK: Senator Vard Johnson is going to handle it for him, I believe.

SENATOR CLARK: Senator Johnson, do you want to handle the amendment?

SENATOR VARD JOHNSON: Yes. Mr. Speaker and members of the body, my officemate, Senator Hoagland, has prepared an amendment to 592. He is not here this morning so I will carry the amendment. The amendment itself has been photocopied and you will see a copy on your desk. This amendment came to Senator Hoagland from the Director of the Department of Correctional Services, Mr. Charles Benson. The amendment would do this, as you can read from what is on your desk, it would remove from 83-466 the expression "mendicancy or". Now what 83-466 says is this, whenever a boy of sane mind, not a girl, mind you, but whenever a boy of sane mind and less than eighteen years old is growing up in mendicancy or crime because of a want of proper parental care or other cause, and a complaint therefor has been filed in a court of record in this state, the court may enter an order committing the boy to the Youth Development Center in Kearney. Okay, that is essentially what it is. Mr. Benson has said that there hasn't been anybody in years who has been put into

the Youth Development Center in Kearney for mendicancy. Mendicancy, incidentally, is being a beggar. Now apparently years ago in our society we had little street gamins who went out with caps in hands, these were the early day Horatio Algiers, and they begged and somehow our society didn't like that and so we decided that we would take those little fellows, and if they were beggars, we would put them in this Youth Development Center in Kearney, and that is as simple as that. But we haven't had street beggars of that kind for years and years and years and I suspect that our sensibilities about such folk have changed. Anyhow Mr. Benson thinks they have so he says this is an obsolete provision and it ought to be dropped from the statutes. And as I looked at it, I said, "Boy, this sure is obsolete", and I would recommend that we drop this from the statute in our obsolete statute repeal bill. I would offer this amendment.

SENATOR CLARK: Senator Lamb.

SENATOR LAMB: Mr. President, members, we had the bill drafter check this amendment that Senator Hoagland and Senator Johnson have offered and she has concurred that it could properly fall within this bill and so I have no objection to the amendment offered.

SENATOR CLARK: Senator Fowler.

SENATOR FOWLER: A question of Senator Johnson.

SENATOR CLARK: Senator Johnson, will you yield?

SENATOR JOHNSON: Of course I will yield if Senator Fowler begs me.

SENATOR FOWLER: Yes, I beg you now that it is legal. You indicate that it only applies to boys, is that correct?

SENATOR V. JOHNSON: That is correct.

SENATOR FOWLER: Then why does your amendment on line 16 add "or her".

SENATOR V. JOHNSON: I hadn't read that far in the amendment but I suppose that is done for the purpose of taking care of some kinds of boys who may masquerade in women's clothing.

SENATOR FOWLER: Is that a crime?

SENATOR V. JOHNSON: No, that is not a crime. I don't know, Senator Fowler.
