The Clerk will just read some bills in until...it's getting close enough to the time of the Governor's arrival. We will proceed with the reading of some bills, Mr. Clerk.

PRESIDENT: Does anyone else have any bills to introduce before the Governor's arrival? We just as well get in the bills if you have any there. The Clerk would like to read them in.

That is signed by Senator Kahle). (See pages 641 through 644 of the Journal).

Your committee on Banking whose Chairman is Senator DeCamp to whom was referred LB 708 instructs me to report LB 708 advanced to General File with committee amendments attached, and LB 751 advanced to General File with committee amendments attached. (See pages 645 and 646 of the Journal). Those are signed by Senator DeCamp.

Your committee on Public Works whose Chairman is Senator Kremer to whom was referred LB 655 instructs me to report that bill as advanced to General File with committee amendments attached. That is signed by Senator Kremer. (See page 647 of the Journal).

Mr. President, your committee on Enrollment and Review respectfully reports they have carefully examined and reviewed LB 623 and recommend that same be placed on March 15, 1982

PRESIDENT: Okay, so the motion is the adoption of the committee amendments which as you said are the bill. All those in favor vote aye, opposed nay. Record the vote.

CLERK: 27 ayes, 0 nays, Mr. President, on adoption of the committee amendments.

PRESIDENT: All right, now we're on the bill itself. Senator DeCamp, do you have anything further? Senator Vickers, do you want to speak to the bill? No. Senator Schmit, anything? CLERK: Mr. President, LB 751 offered by Senator Goodrich. (Read title.) The bill was read on January 11, referred to Banking, Commerce and Insurance. The bill was advanced to General File, Mr. President. There are committee amendments pending by the Banking Committee.

PRESIDENT: Senator DeCamp, the Chair recognizes you for purposes of discussing the committee amendments to LB 751.

SENATOR DeCAMP: Oh, Mr. President, as I recall this is the loan broker thing which we've had more than a little trouble in this state on, people saying they're going to find somebody money and charging them piles of dollars. We had one scandal after another that the Attorney General has been dealing with. We think we've got legislation put together tc correct it. The Wesely amendment on this bill simply says that it would fall under the Consumer Protection Act which we've got an Attorney General's opinion #208 saying unless we put this amendment, unless we specifically say it, it won't fall under that so the amendment makes it specifically fall under the Consumer Protection Act. I urge you to adopt it.

PRESIDENT: Any further discussion? Senator Schmit? Senator Wesely first and then Senator Schmit. Senator Wesely, on the committee amendments.

SENATOR WESELY: Yes. Mr. President, members of the Legislature, the Attorney General's office was contacted. They did

provide an opinion which was dated February 26 where they called for the need to expand the Consumer Protection Act to cover loan brokers. They had been involved and then we did want to continue to involve the Attorney General's office in this serious problem but we found that there was some language in the bill we passed 'ast year that there was some doubt as to whether or not they could still be involved in loan broker regulation. This would clarify the Consumer Protection Act. It would continue to cover loan brokers and the Attorney General could continue to be involved in that issue. It is an important amendment and is supported by the Attorney General's office.

PRESIDENT: Any further discussion on the committee amendments to LB 751? Senator DeCamp, do you wish to close on the committee amendments? The motion is the adoption of the committee amendments on LB 751. All those in favor vote aye, opposed nay. Have you all voted? Record the vote.

CLERK: 25 ayes, 0 nays on adoption of committee amendments, Mr. President.

PRESIDENT: The motion carries. The committee amendments are adopted. The Chair would like to introduce from Senator Landis' district some 46 fourth graders from Hartley Elementary School with Norma Tumblin, Debbie Cone and Linda Greenwald are teachers. They are up here in the North balcony and we welcome you to your unicameral Legislature, Hartley School. The Chair now recognizes Senator Goodrich to present the bill.

SENATOR GOODRICH: The bill itself, now that we have adopted this amendment and it has just been explained to you, I'll explain the original bill itself which is nothing but a way of picking up the subsidiaries of savings and loans and putting them over in the sections where savings and loans are regulated. Originally when savings and loans were given like their special set of statutes, banks were given theirs, the whole thing was...we spelled out in other words, banks, trust companies, savings and loans, that sort of thing should be regulated over here in this section but we forgot to pick up the subsidiaries of savings and loans. So literally the Banking Department doesn't know whether to regulate them under this particular section of statutes, these subsidiaries I mean, under this section of statutes or over in the savings and loan sectionswhere they belong. So all the intended to do is just transfer them over there bill is where they belong so that they will be regulated like savings and loans. I move we advance the bill.

SENATOR LANDIS: Mr. Speaker, members of the Legislature, LB 875 was brought to the Urban Affairs Committee by Senator Wiley Remmers and it indicates that in second class cities and villages there shall be the power to take private property for public use for the purpose of electrical distribution facilities and this is simply to make the grant of authority clearer as to when condemnation can be used and for what public purposes. The existing language indicates that water works, gas works, power plants, electric or other light works and such plants are covered but they do not make it explicit that electrical distribution facilities are covered and of course I think we would all intend for those definitions to include that situation. The committee agreed with Senator Remmers as to the need for the bill and also searched the statutes to find that first class cities did not have this kind of explicit language in its provisions. So rather than taking second class cities this year and then perhaps be faced with making the same change a year or two down the road for first class cities, the committee adopted the rule that this should apply for first class cities as well. The committee amendments extend the provision for this act to first class cities as well and that is without objection from any known party. The League of Municipalities at the hearing, when asked about the amendment, the proposed amendment, agreed fully with it and it has the acquiescence of all parties to the bill that I know of.
