SENATOR SCHMIT: Thank you.

SENATOR CLARK: The time is up on the bill. We will pass to the next bill, 909. We have other speakers, Senator Koch.

SENATOR KOCH: Senator Clark, may I ask for a vote up or down?

SENATOR CLARK: No. Not with more speakers on. That is not what the speaker has said. Is Senator Goll here today? Okay, we will take 909.

CLERK: Mr. President, LB 909 offered by Senator Goll. (Read title.) The bill was read on January 19th of this year, referred to the Urban Affairs Committee. The bill was advanced to General File, Mr. President. There are committee amendments by the Urban Affairs Committee pending.

SENATOR CLARK: Senator Landis, on the committee amendments.

SENATOR LANDIS: Mr. Speaker, members of the Legislature, we made a couple of correcting or technical changes to narrow at least in one respect the range of the bill and that was to delete the provision "in accordance with and in compliance"...we exchanged the word "compliance" rather than "accordance with" and that was a mandated sale or bringing something in compliance with some federal language and also we struck or we added rather language that said "property which consists of streets and alleys". There, for example, when a street is closed and you will want to sell that land back to the adjacent landholders, there is no necessity for a public sale because, of course, that land is only of value to the people who abut the now closed alley or street. We also made a further provision at the suggestion of the committee, Senator Cullan's idea really, to allow for the sale of personal property which in its aggregate market value does not exceed a thousand dollars and this would not be necessary for a public sale but we could have the posting of a sale for seven or more days in a village and in so doing permit them to sell an old typewriter, some office equipment or the like. Lastly, I was trying to remember what language we struck. We also struck language stating that you sould use provisions other than an auction or a sealed bid for areas...for sales which serve the community betterment purposes. That language was too broad in the opinion of the committee and it covered too much area. So we nailed down those kinds of provisions when you could utilize a sale mechanism, a direct sale mechanism to a more limited range. We deleted the one on community betterment purposes. We put in its place the sale of closed public streets or alleys and we

put in this provision up to \$1,000 personal property being sold without having to utilize these kinds of costly and involved sale procedures, and we also added the emergency clause to the committee...rather to the bill. If you take a look at the proponents, we asked those proponents if they agreed with the proposals that the committee was talking about among themselves. They all agreed. To my knowledge, the committee amendments are agreed upon by all interested parties including the introducer. I move their adoption.

SENATOR CLARK: I would like to introduce Carson Rogers and daughter Regina from Ord, Nebraska, friends of Senator Wagner. Will you stand and be recognized please. Welcome to the Unicameral. The question before the House is the adoption of the committee amendments. All those in favor vote aye, opposed vote nay.

ASSISTANT CLERK: Senator Clark voting yes.

SENATOR CLARK: Record the vote.

ASSISTANT CLERK: 27 ayes, 0 nays on the motion to adopt the committee amendments, Mr. President.

SENATOR CLARK: The committee amendments are adopted. On the bill, Senator Goll.

SENATOR GOLL: Mr. Speaker, members of the Legislature, LB 909 notwithstanding its own merits has three aspects that should delight the Legislature. Number one, it has no fiscal impact. It doesn't cost any money. Number two, it is noncontroversial. Nobody is against it. And number three, number three, we are deleting a little portion of the statute and combining it all into one thing. So I would immediately following my presentation ask for your affirmative vote on LB 909, and what it does is amend two sections relating to the sale of public property in second class cities and villages. It establishes one clear, precise procedure for doing this. It also as Senator Landis explained in the amendment empowers these villages and second class cities to dispose of personal property through a regular procedure. They can do this by sealed bids. They can do it by public auction. Notices are published and posted and certain procedures must be followed according to the legislation. Once a sale is made, once it is consummated, it is final. We are in fact eliminating a controversial part of a statute which because of prior legislation established a conflict in the way these cities and villages could dispose of their real estate and personal property. I would, therefore, ask for your affirmative vote on LB 909. Thank you.

SENATOR CLARK: Senator Carsten on the committee amendments.

SENATOR CARSTEN: Mr. President, I would move for the adoption of the committee amendments. LB 480 was introduced as the Clerk has said last year, and because of the contents of the bill, the committee felt that it should be studied through the interim and was, and as a result, you have before you the committee amendments as was dictated by the interim study. The committee amendment does basically three things. First it transfers to the surviving spouse...transfers to the surviving spouses are exempted from the inheritance tax and this is the same as the federal estate tax law. Second, the provision regarding inclusion of gifts made within three years prior to the death is modified to conform to the federal estate tax law. That is transfers requiring filing of a federal gift tax return only would be included in the estate for tax purposes. And, thirdly, various obsolete language relating to county's use of inheritance tax receipts and other miscellaneous items in the inheritance and estate taxes is repealed. This basically brings this bill into compliance and in accordance with the federal level and I again would move for the adoption of these amendments.
