SENATOR KAHLE: Mr. Speaker and members, it is certainly not my intention to run out of time. I just have a...as I look at the bill and perhaps maybe a question of Senator Schmit, it does include the wheat checkoff, corn checkoff and the milo checkoff, does it not? He nods yes. I have always been an advocate of checkoffs and I am sorry, I guess, that we don't have better markets today, but we may have a poorer market if we didn't have the checkoffs. But I have, as Senator Cullan has mentioned, some misgivings about using that money for ... certainly for gasohol plants at the present time, and I guess I am kind of concerned about these. T look at the committee statement where we have Ed Schrock, for instance, of the Corngrowers testifying for it and I know or think he is against this very thing of using the money for gasohol production. And, of course, we have the farmers organizations that are against it, at least some of them. So I guess I would resist at least part of the bill and perhaps it should be amended.

SPEAKER MARVEL: Okay, we turn to LB 962.

CLERK: LB 962 introduced by Senator Schmit, Hefner, VonMinden. (Read title.) The bill was read on January 19th. It was referred to Ag and Environment. The bill was advanced to General File, Mr. President. I have no amendments on the bill.

SENATOR SCHMIT: Mr. President and members of the Legislature, this bill like many others has been around many, many times. At the present time it has several new wrinkles in it. Section 1 is very simple. It establishes the intent of the bill, and Section 2 has domestic firms, corporations and partnerships as well as individuals. It is a list of entities that would be afforded agistor lien protection. The section also modernizes various provisions regarding foreclosures of liens. Section 2 grants a first agistor's lien to domestic feeders when they feed cattle belonging to nonresidents. In other words, if I live...if I am operating a cattle feedlot and someone from Kansas ships cattle into Nebraska into my feedlot, it gives me a first lien on those cattle for the feed that I provide for In the past we have had other versions of the bill them. which have been opposed by the Bankers Association. This bill is supported by both the Nebraska Bankers Association and the Livestock Feeders Association. I am not familiar whether or not there was opposition at the hearing, but, very frankly, I believe the bill is a good bill, deserves to be advanced to Select File. I ask your support of the bill. In fact, Mr. President, there was no opposition to the bill.

SPEAKER MARVEL: Senator Hefner.

SENATOR HEFNER: Mr. President and members of the Legislature, I rise to support this bill. I am cosponsor of it, and I think it will help the livestock industry in Nebraska. I have tried to get some...I tried to get a bill passed several years ago and ran into problems with the Banking Association and now we have come to an agreement and, in fact, the Bankers Association spoke for the bill, and so, therefore, I would urge you to advance this bill.
