CLERK: Mr. President, your committee on Education reports LB 572 to General File with committee amendments attached. (See page 401 of the Journal`.

Mr. President, Urban Affairs reports LB 698 as indefinitely postponed.

Mr. President, new resolution, LR 208. (Read LR 208 as found on page 402 of the Legislative Journal). That will be laid over, Mr. President. LR 209 signed by Senator Haberman and several members. (Read LR 209 as found on pages 402 and 403 of the Journal). Mr. President, that too will be laid over.

SENATOR V. JOHNSON: Yes, I would request a Call of the House, Mr. President.

PRESIDENT: Alright, the motion is, shall the House go under Call. All those in favor vote aye, opposed nay. The motion is for the House to go under Call. Have you all voted on the Call? Record the vote.

CLERK: 17 ayes, 0 nays to go under Call, Mr. President.

PRESIDENT: The motion carries. The House is under Call. The Sergeant at Arms will see that all legislators who are not at their desks will be in the chamber at their desks. All members of the Legislature will register your presence. All unauthorized personnel will leave the floor. The House is under Call. There are approximately eleven legislators excused. We're looking for Senator DeCamp, Senator Haberman. Senator Kilgarin, are you here? Senator John, would you...

SENATOR V. JOHNSON: (inaudible)...roll call vote.

PRESIDENT: Alright, we're down to that now so we'll have a roll call vote. Alright, a request has been made to read the resolution. Mr. Clerk, would you read the resolution and then we're going to have a roll call vote as requested. Read the resolution. The House is under Call.

CLERK: (Read LR 208.) The resolution is on page 402 of the Journal, Mr. President. (Read roll call vote as found on page 448 of the Legislative Journal.) 19 ayes, 19 nays Mr. President, on adoption of the resolution.

PRESIDENT: The motion fails. The resolution is not adopted. Before we go to the next resolution the Chair would like to introduce some guest of Senator Haberman. Under the South balcony is Karla Radeliff, Cindy Bullock and Mike Milder, II. Would all three of you stand up and be recognized. Welcome to your Unicameral. And do you want the Call raised? Senator Vickers wants the Call raised so the Call is raised. We will proceed then with the LR 209, Mr. Clerk.

CLERK: Mr. President, LR 209 offered by Senator Haberman and a number of senators. (Read.)

PRESIDENT: The Chair recognizes Senator Haberman.

SENATOR HABERMAN: Mr. President, members of the Legislature. I was very flattered and pleased to offer this resolution on behalf of the Nebraska Jaycees and what we are attempting to do here as you know is to name Interstate 480 after Gerald R. Ford, name it the Gerald R. Ford Expressway as he was the United States President and is born in Nebraska. And the Nebraska State Jaycees and myself and the other senators who signed the resolution, we're really only doing what they have done in Grand Rapids, Michigan, where they have the G.R. Ford Expressway. We are doing what they did in Detroit where they have the Edsel Ford Freeway, I-94. They also have the Chrysler Freeway, I-75, the John C. Lodge, U.S. #10. We have the Eisenhower Expressway in Chicago, the Harry Truman Expressway in Missouri and a whole bunch of other expressways and freeways and United States highways named after famous people living and dead, and, therefore, I feel that we should pass this resolution as it merely states that the state engineer is urged to initiate the procedure to affect the designation of Interstate 480 as Gerald R. Ford Expressway. I would like to add that Governor Thone late yesterday afternoon gave me his positive personal and enthusiastic support of this resolution. Therefore, members of the Nebraska Legislature, I ask you to vote yes on LR 209. Thank you. Mr. President.

PRESIDENT: The Chair recognizes Senator Wesely.

SENATOR WESELY: Mr. President, members of the Legislature, I have one question if Senator Haberman would yield please.

PRESIDENT: Senator Haterman, will you respond?

SENATOR HABERMAN: I would be very pleased to respond to fine young Senator Wesely.

SENATOR WESELY: Senator Haberman, I have only once concern with this resolution. If we name this expressway for former President Ford, will it happen to turn out to be accident prone?

SENATOR HABERMAN: I didn't hear you. My hearing aid is broke, I didn't hear you.

SENATOR WESELY: Do you think that if we name this expressway for President Ford that it may turn out to be accident prone?

SENATOR HABERMAN: I understand that he doesn't hit his head on the doorways of airplanes anymore and I don't think we will have any problems along that line.

PRESIDENT: The Chair recognizes Senator Newell,

SENATOR NEWELL: Mr. President and members of the body, I'm going to support this resolution even though I have a few complaints about the way it was handled. You know this Legislature in my opinion is becoming increasingly partisan. I mean it has become so partisan that Senator Haberman never even asked me if I would be willing to sign this resolution. SENATOR NEWELL: Senator Haberman came to me afterwards and said, "Say, Dave, we introduced this resolution and I hope you won't oppose it." I think that that is prejudging in the worst way and I think that not only have I been prejudged, just because I happen to be a registered Democrat, I can't take pride in a hometown boy. That really hurts and I would ask the rest of this body to be a little more sensitive on these very important issues and I would ask Senator Haberman specifically if he would apologize for his oversight.

PRESIDENT: Senator Haberman, I don't know if that was asking you to respond or not but you have a chance to do that.

SENATOR HABERMAN: Mr. President, members of the Legislature, it is unfortunate at this time that Senator Newell has to bring up partisan politics. As I go into Omaha and every time I go into Omaha I see something that says something about Kennedy Road going somewhere. I think he belongs to the Democratic party. When I went through the chamber to get the names, DeCamp wasn't here and my good friend Senator Newell wasn't here when I handed the petition in. Senator Goodrich wasn't here. I went up and told him about the petition if he wanted to get his name on it. So, I'm sorry, Senator Newell, that I did not give you the opportunity to sign it and I know that you would have signed it out of the spirit of being a fair and honest legislator. PRESIDENT: Alright. Senator Goodrich.

SENATOR GOODRICH: Mr. President, members of the body, I rise in support of the resolution. I would like to acknowledge that Senator Haberman did come to me and

PRESIDENT: Senator Goodrich has asked unanimous consent to add his name and so does Senator Newell so we'll take them up. Is there any objection? We'll give you a chance to take the names off too but those that want to have their names added, let's have them added at this time. Senator Labedz.

SENATOR LABEDZ: Yes.

PRESIDENT: Do you want your name on too?

SENATOR LABEDZ: Well I would like to ask Senator Haberman a question first.

PRESIDENT: Oh, alright.

SENATOR LABEDZ: Would you respond?

SENATOR HABERMAN: I will respond as long as it is not a partisan or nonpartisan question, yes.

SENATOR LABEDZ: As a Democrat I would love to have my name on the resolution but first I would like to ask Senator Haberman if he is going to support studded snow tires to be used on the Ford Freeway.
