PRESIDENT: The Chair recognizes Senator VonMinden.

SENATOR VON MINDEN: Mr. President and members of the body, I introduced this resolution because I feel that it is appropriate for this body to recognize the many years of dedicated service which Dr. Seymour has given to Wayne State College. In one capacity or another he has served Wayne State College for 30 years. After serving nine years as President of Wayne State, Dr. Seymour is resigning in order to take a position with the Wayne State Foundation where he will continue to work for the betterment of the college. During his tenure as President, Dr. Seymour has gained respect and admiration of the citizens of northeast Nebraska for his accomplishments in making Wayne State College the excellent educational institution that it is today. By the way, my son graduated from Wayne State and my aide graduated from Wayne State in '78. I urge everyone to join with me in voting for this resolution to honor Dr. Seymour. Thank you.

PRESIDENT: Anything further on LR 257? Senator Hefner.

SENATOR HEFNER: Mr. President, I would like to ask the Clerk to add my name to this resolution.

PRESIDENT: You want to add your name. Any objections? So ordered. Senator VonMinden, do you want to close? The question then is the adoption of LR 257. All those in favor vote aye, opposed nay. Record the vote.

CLERK: 32 ayes, 0 nays, Mr. President.

PRESIDENT: The motion carries and LB 257 is adopted. The next resolution is LB 258, Mr. Clerk.

CLERK: Mr. President, LR 258 offered by Senators Cullan, Wesely and Rumery. (Read LR 258.) Mr. President, that resolution is on page 1322 of the Journal.

PRESIDENT: The Chair recognizes Senator Wesely.

SENATOR WESELY: Thank you, Mr. President, and members of the Legislature. This resolution was introduced by myself, Senator Cullan and Senator Rumery because of the concern that was shared with us by many constituents who are railroad retirees who are aware of the proposed changes in the retirement system that is now in effect for railroad retirees.

The President is proposing a number of changes and a conversion from a federal oversight function to one that would be dispersed among different agencies including a private corporation. And it is quite clear that what is now a national uniform system would be changed dramatically and there is a lot of questions about whether or not that is a good idea. There is a great deal of concern amongst railroad retirees as to whether or not they are going to lose benefits and whether those that have paid in are going to get back what they expected, and I think we ought to adopt this resolution just to call for Congress and the President to be very, very careful before they take any steps whatsoever in changing the system that has worked so well for the national retirees from our railroads. So that is the resolution. I urge your support.

PRESIDENT: Any further discussion on LR 258? Hearing none, Senator Wesely, I guess that is the closing. The question then is the adoption of LR 258. All those in favor vote aye, opposed nay. Have you all voted? Record the vote.

CLERK: 29 ayes, 0 nays, Mr. President, on adoption of the resolution.

PRESIDENT: Motion carries and LR 258 is adopted. The next resolution is LR 259. LR 259.

CLERK: Mr. President, LR 259 is offered by Senator Haberman. It is found on page 1343 of the Journal. (Read LR 259.) Mr. President, that is on page 1343 of the Journal.

SENATOR HABERMAN: Mr. President and members of the Legislature, we always leave the best till last. Grant, or the Plainsmen, have won the Class C tournament two years in a row.
