PRESIDENT: Senator Dworak, you wish to withdraw the amendment. Senator Dworak is withdrawing his amendment which was in the Journal and the amendment is withdrawn. So we will now proceed, Mr. Clerk, with the reading of LB 631.

CLERK: (Read LB 631 on Final Reading.)

PRESIDENT: All provisions of law relative to procedure having been complied, the question is, shall LB 631 pass with the emergency clause attached? All those in favor vote aye, opposed nay. Have you all voted? Record the vote.

CLERK: (Read the record vote as found on pages 1342 and 1343 of the Legislative Journal.) 38 ayes, 6 nays, 4 excused and not voting, 1 present and not voting, Mr. President:

PRESIDENT: LB 631 passes with the emergency clause attached. That will conclude Final Reading this morning. Before we take up agenda item #6, the Chair would like to introduce 70 students of the Youth Citizenship Seminar. This is group number two of the Nebraska Farm Bureau representing some 62 counties of our State of Nebraska and they are up here in the south balcony. We welcome you to your Legislature. Welcome. The Clerk will have some matters to read into the record. Proceed to do so.

CLERK: Mr. President, new resolution, LR 259, offered by Senator Haberman. (Read LR 259 as found on page 1343 of the Legislative Journal.) That will be laid over, Mr. President.

Mr. President, legislative bills read this morning on Final Reading are now ready for your signature.

PRESIDENT: While the Legislature is in session and capable of transacting business, I propose to sign and I do sign LB 259, 642, 644, 678, 696, 767, 767A, 775, 776, 828, 845 and 631. Ready then, Mr. Clerk, for agenda item #6, motions, LB 731. March 24, 1982

The President is proposing a number of changes and a conversion from a federal oversight function to one that would be dispersed among different agencies including a private corporation. And it is quite clear that what is now a national uniform system would be changed dramatically and there is a lot of questions about whether or not that is a good idea. There is a great deal of concern amongst railroad retirees as to whether or not they are going to lose benefits and whether those that have paid in are going to get back what they expected, and I think we ought to adopt this resolution just to call for Congress and the President to be very, very careful before they take any steps whatsoever in changing the system that has worked so well for the national retirees from our railroads. So that is the resolution. I urge your support.

PRESIDENT: Any further discussion on LR 258? Hearing none, Senator Wesely, I guess that is the closing. The question then is the adoption of LR 258. All those in favor vote aye, opposed nay. Have you all voted? Record the vote.

CLERK: 29 ayes, 0 nays, Mr. President, on adoption of the resolution.

PRESIDENT: Motion carries and LR 258 is adopted. The next resolution is LR 259. LR 259.

CLERK: Mr. President, LR 259 is offered by Senator Haberman. It is found on page 1343 of the Journal. (Read LR 259.) Mr. President, that is on page 1343 of the Journal.

PRESIDENT: The Chair recognizes Senator Haberman.

SENATOR HABERMAN: Mr. President and members of the Legislature, we always leave the best till last. Grant, or the Plainsmen, have won the Class C tournament two years in a row. PRESIDENT: Okay.

SENATOR HABERMAN: But, however, I will say this, this body some years ago said if we increase the cigarette tax and build a facility then we will be able to recruit good players. So this body increased the cigarette tax. We built that facility but it doesn't seem that we are keeping the good players. So thank you very much and I would still like to have a large vote on this for the Grant Plainsmen.

PRESIDENT: That's right. The Chair is not supposed to agree but he agrees. Okay, all those in favor of LR 259 vote aye, opposed nay. Record the vote.

CLERK: 32 ayes, 0 nays, Mr. President, on adoption of the resolution.

PRESIDENT: The motion carries and LR 259 is adopted. The next resolution is LR 260.

CLERK: Mr. President, LR 260 offered by Senator Kremer. It is on page 1348. (Read LR 260.)

PRESIDENT: The Chair recognizes Senator Kremer.

SENATOR KREMER: Thank you, Mr. Chairman. Senator Haberman just said we always leave the best till last and I am glad he recognizes that. Likewise the Hordeville High School has a very fine bunch of boys playing basketball this year and they too for the second time won the Class D championship and deserve the same recognition we have given these other fine teams that have gone through this basketball season and came out with this glorious victory.
