Mr. President, your Committee on E & R respectfully reports we have carefully examined and engrossed LB 970 and find the same correctly engrossed. 970A correctly engrossed.

Mr. President a new resolution LR 293 (read title). LR 294 (read title). LR 295 (read title). All were laid over.

SENATOR LAMB: If I could have your attention for just a few minutes. As you probably know we have a number of priority bills that have not been considered at this point. We have a number of revenue bills and appropriation bills that need further work and so our time is pretty short. In order to consider this whole situation we are scheduling a meeting of the chairmen at noon today in Room 2102, so we can discuss the whole situation and come up with some possible solutions.

SENATOR CLARK: The first bill we are going to take up under item number four, General File, will be 520A.

CLERK: Mr. President 520A was a bill introduced by Senator Vard Johnson. (Read title). I have an amendment from Senator Johnson to the bill, Mr. President.

SENATOR CLARK: Senator Johnson.

SENATOR JOHNSON: Mr. Speaker, members of the body, LB 520 is a bill that deals with child care and licensing thereof. During the first round debate on LB 520 Senator Cope asked me what I thought this bill would ultimately cost. I indicated

SENATOR BARRETT: Mr. President and members, many of you have probably noticed the series of six prints which are on permanent display in the Moses P. Kinkaid hearing room number 1520 Senator Koch. These, this series of print is entitled "From Sea to Shining Sea", and is made possible by Mr. John Falter the artist the former native of Plattsmouth, Nebraska, born in Plattsmouth in about 1910 now living with his wife in Philadelphia and still actively painting. The gift, this outstanding gift was made possible on the occasion of the 50th Anniversary of the State Capitol Building by Mr. Cliff Hillegass of Lincoln, Nebraska. So this resolution simply is an official thank you to Mr. Hillegass for his most generous contribution to the State of Nebraska, also recognizes Mr. Falter the artist for his talent and the beautiful prints which are now permanently a part of the state property. So I'm pleased to join with Senators Remmers and Lamb in the introduction of this resolution. I move the adoption.

SENATOR CLARK: Question before the House is the adoption of the resolution. All those in favor vote aye, opposed vote nay. Voting aye. Record the vote.

CLERK: 27 ayes, 0 nays on adoption of the resolution, Mr. President.

SENATOR CLARK: The resolution is adopted. LR 293, by Senator Higgins, is she here?

CLERK: Mr. President, Senator Labedz and Higgins move to offer 293, it is on page 1610.

SENATOR CLARK: Senator Labedz.

SENATOR LABEDZ: Thank you, Mr. President. LR 293 is a very brief resolution to commend and congratulate the Forensics Team of the University of Nebraska at Lincoln for their outstanding season, especially the teams first place finish last month in the Delta Sigma Rho-Tau Kappa Alpha

National Forensics Competition in Lubbock, Texas. The Nebraska team which is coached by Dr. Jack Kay won the tourney sweepstakes trophy by out pointing its nearest opponent Alabama U by nearly 40 points. This resolution is sponsored by myself and Senator Higgins congratulates the team for outstanding debate and public speaking skills in varsity competition. I ask you and the members of the Legislature to salute these fine young people in their contribution to the academic reputation of the University of Nebraska.

SENATOR CLARK: Senator Koch.

SENATOR KOCH: A question of Senator Labedz.

SENATOR CLARK: Senator Labedz.

SENATOR LABEDZ: I don't know. SENATOR RUMERY: Mr. President, members of the Legislature, I would like to say that I am extremely honored that the Senator from Farnam would consider doing us the honor of helping us sponsor this. Glad to have him aboard and would be glad to have the rest of you aboard that would like to join in with us. This is a thing that we started last year of honoring the Unknown Indian in the country for contributions they have made to society. Last year we were extremely fortunate in finding an Indian who was a graduate in Chemical Engineering and he has now established his own business in California and he is taking the material that other manufacturers threw away and has built them into worth while products. We hope to continue this this year. The honoree has not been selected yet, but we would like to establish May 30th as Unknown Indian Day. Some of you may know that we have an Indian statue on Sioux Lookout which is southeast of North Platte and was mutilated a little bit and a friend of mine by the name of Jack Fletcher came back who grew up in that area and saw how it was treated and he wanted to know if we couldn't restore it and he has been working with the Lincoln County Historical Society to do this and he went beyond this and we were successful in selecting an Indian who was...who made great contributions to society and would like to do the same this year. Mr. President, I move the adoption of the resolution.
