PRESIDENT: We are ready for agenda item #4, resolutions. Mr. Clerk, you may read the first resolution, LR 9.

CLERK: Mr. President, LR 9 is found on page 351 of the Journal and it reads as follows: (Read resolution.) Again, Mr. President, it is found on page 351 of the Journal.

PRESIDENT: The Chair recognizes Senator Carsten.

SENATOR CARSTEN: Mr. President and members of the Legislature, I certainly would move for the adoption of this resolution. Bess Streeter Aldrich's hometown of Elmwood is celebrating her centennial this year and we all know that Bess Streeter Aldrich is well known, not only in Nebraska, but throughout the land for her writings and certainly is a credit to Nebraska and to the town of Elmwood. Elmwood is not in my district yet. It is in Senator Warner's District. We anticipate that there may be a possibility that it will be in the next reapportionment, but be that as it may, Senator Warner and I both introduced this resolution on behalf of the City of Elmwood in recognition of this grand lady that is so well known. I certainly urge you to adopt this resolution. Thank you.

PRESIDENT: The Chair recognizes Senator Kahle.

SENATOR KAHLE: Mr. President, members, you probably wonder how I would get involved with an issue at Elmwood, Nebraska, and with Bess Streeter Aldrich. My mother grew up in Elmwood, Nebraska, and was a personal friend of Bess Streeter Aldrich's and did sewing in her younger days and sewed for Bess Streeter Aldrich and was in her home the first day that she received a check for writing. So I have a deep interest in what is going on this morning and certainly hope that you will pass this resolution and I am sure that we all extend congratulations to Elmwood, Nebraska, for being the home of such a fine lady. Thank you.

PRESIDENT: Is there any further discussion on LR 9? Seeing and hearing none, Senator Carsten do you wish to close? No closing, so the question before the House is the passage of LR 9. All those in favor of LR 9 vote aye, opposed nay. Have you all voted? Record the vote.

SENATOR RUMERY: Mr. President, members of the Legislature, Mr. President, I wonder if we might have a little quiet around here.

PRESIDENT: All right. I think it is probably a good idea. We are getting a terrible roar. (Gavel) Could we have a little bit more order.

SENATOR RUMERY: Thank you, ladies and gentlemen. I have submitted this resolution for the purpose of urging the Medical Center and the Institute of Agriculture to cooperate in these problems that are confronting the people of this country as well as others, the problems of controlling cancer. It has been discovered that there are cancer in some of the livestock. Livestock and humans are quite similar and we think that there is a possibility that this ought to be enlarged upon and that we'd like to ask these two institutions to pool their resources and work together on this, and then if they are able to do this, there is a possibility that there'd be some federal funds that would be available for cancer research. Mr. President, I move the adoption of this resolution.

PRESIDENT: Is there any further discussion on Legislative Resolution #10. Seeing none, Senator Rumery, I guess the opening will be the closing and the question before the House is the adoption of LR 10. All those in favor vote aye, opposed nay. Have you all voted? Record the vote, Mr. Clerk.

CLERK: 36 ayes, 0 nays, Mr. President, on the adoption of the resolution.

PRESIDENT: Motion carries and Legislative Resolution #10 is adopted. The next resolution is resolution, LR 12. The Clerk may read it.

SPEAKER MARVEL: While the Legislature is in session I am about to sign and do sign LR 4, LR 9, LR 10, LR 13, LR 14, LB 1, LB 2, LB 60, LB 71, LB 57 and LB 141.

CLERK: Mr. President, I have a reference report referring LB 543 and LR 12; rereferring LB 526 as well as a number of gubernatorial appointments. (See pages 441-442 of the Journal.)

Finally, Mr. President, I have a report from the Thurston County Sheriff's Department pursuant to statutory section 23-362.

SPEAKER MARVEL: Senator Warner is excused today so we are going to pass over #4, item #4 and move to item #5 which is General File and the first order of business is LB 165A.

CLERK: Read LB 165A.

SPEAKER MARVEL: Senator Lamb.
