SENATOR WESELY: Thank you, Mr. Speaker. I would like to call the attention of the Legislature to one final rule change and when we are done with this we will be left with only a handful of rule changes that are pending by Senator Chambers and then we will be able to complete that activity tomorrow. So if we can just take care of this one last rule change, we can adjourn for the day and deal with the final few rule changes tomorrow. The rule change that I am calling to your attention now and which I move at this point for adoption concerns Section...Rule 3, Section 15 of the Rule Book. That is on page 19. This is an amendment brought to you by myself. It was worked out with members of the media of Nebraska and also Senator Beutler and other interested Senators. This was a concern that there was some uncertainty as to the language in the present executive session section of the rules as to what the media could or could not cover. The concern was that in the past when you have an executive session the media could be present and could report on discussion and action taken by the committee. Unfortunately there was a rule change last session that deleted the discussion part of the coverage option for the media and it was felt that that was important to reinsert. Now that is one of the rule changes that is incorporated here. The other is when you close an executive session to everybody including the media, I add the word "rare" to the

out of the general fund today, why we'd all be working at it. Well I'm telling you, this is a \$50 million minimum savings over the not too distant future. Anyone that has doubts I can take and show you, show you the cases, names crossed out but you won't have any doubt once you read them what is going on. This needs to be done. I urge you to do it because remember this final fact. Insurance companies are simply an agency for collecting a lot of money and paying it out. They are going to always collect long-term, whether it is two, three, five years more, that is their profit, than they pay out. If they are paying out \$50 million fraudulently they're going to collect \$50 million fraudulently from everybody in the state and that is what is occurring. This is a major savings in cost containment for the state. It will help in your medical insurance. It will help in the overall medical costs. I urge you to adopt it.

SPEAKER MARVEL PRESIDING

SPEAKER MARVEL: The next bill is LB 139.

CLERK: (Read.) The bill was first read on January 13 last year. At that time it was referred to the Banking, Commerce and Insurance Committee for public hearing. The bill was advanced to General File, Mr. President. There are committee amendments pending by the Banking, Commerce and Insurance Committee.

SPEAKER MARVEL: Senator DeCamp.

SENATOR DeCAMP: Mr. President, members of the Legislature, the bill that about a year and a half time has been invested in trying to work out a solution and maybe it is living proof that if you push hard enough long enough you can bring the sides together. I am going to ask to defeat the committee amendments unless your amendment, Senator Marsh... Senator Marsh has an amendment that has been agreed upon by all sides in this controversy from the Insurance Department through the opponents, proponents and so on and so forth. Is your amendment to the committee amendments or is it a separate amendment?

SENATOR MARSH: I believe it is a separate amendment. Patrick, is that the way it is written?

CLERK: Senator, it is written so that it amends the standing committee amendments.

SENATOR MARSH: Then let's just amend the **standing** committee amendment.

SENATOR DeCAMP: Yes, okay then, what I would like to do would be to defer to Senator Marsh. As I say, the amendment that is there represents a settlement by all sides and hopefully instead of taking four hours we can take four minutes on this.

CLERK: Mr. President, Senator Marsh has an amendment to the standing committee amendment found on page 238 of the Legislative Journal, 238.

SPEAKER MARVEL: The Chair recognizes Senator Marsh.

SENATOR MARSH: Thank you, Mr. Speaker. On page 238 is the compromise. I don't see it on that page or maybe I'm not hearing right.

CLERK: Let me check just real quickly. 239, I'm sorry.

SENATOR MARSH: Sorry, Patrick, you'd think I could find it under my own name. The change, ladies and gentlemen, is from \$100 thousand to \$50 thousand in the proposed bill. This is the compromise agreed to by various persons who have an interest in LB 139. I move for its adoption.

SPEAKER MARVEL: The motion is the adoption of the Marsh amendment to the committee amendment as shown on page 239. Senator Marsh, do you have further discussion?

SENATOR MARSH: No.

SPEAKER MARVEL: Okay, the motion is the adoption of the Marsh amendment. All those in favor of that motion vote aye, opposed vote no. Record the vote.

CLERK: 23 ayes, 0 nays on adoption of Senator Marsh's amendment to the committee amendments, Mr. President.

SPEAKER MARVEL: The motion is carried and the Marsh amendment is adopted. Now we take up the committee amendments as amended. Senator DeCamp.

SENATOR DeCAMP: Mr. President, just to say the bill gets into legislating the area of prepaid dental insurance. You know we've done it on legal and just about everything else and with the development of the times, now you've got the dentist with various programs. You watch them on television the same as everybody else. The regulatory fight



had to do with the amount of the bond, whether it should be five thousand, ten thousand as some wanted or a hundred and twenty-five thousand such as the Insurance Department wanted and some of the bigger organizations, I would say, if you want to put it in simple terms, it is the old story, the big versus the little and finally all sides settled or so it was reported to me by the various sides at the sum of fifty thousand as an absolute figure and that is the amendment you just adopted. So I would suggest you adopt the committee amendment now with that amendment and advance the bill.

SPEAKER MARVEL: The motion is the adoption of the committee amendments. All those in favor of that motion vote aye, opposed vote no. Record the vote.

CLERK: 28 ayes, 0 nays on adoption of the amended committee amendments, Mr. President.

SPEAKER MARVEL: The motion is carried, the amendment is adopted. Senator Marsh, do you wish to explain the bill?

SENATOR MARSH: Briefly, Mr. Speaker, LB 139 would authorize prepaid dental service corporations, outline duties of the insurance director as to their establishment and set standards for the corporation. This has been requested by the Nebraska Dental Association, has been a bill thoroughly discussed since last year. I move for its advancement to E & R initial.

SPEAKER MARVEL: Any further discussion? All those in favor of advancing the bill vote aye, opposed vote no. Have you all voted? Record the vote.

CLERK: 27 ayes, 0 nays on the motion to advance the bill, Mr. President.

SPEAKER MARVEL: The motion is carried. The bill is advanced. The next item is 139A.

CLERK: Mr. President, 139A offered by Senator Marsh. (Read title.) Mr. President, I have an amendment to the bill offered by Senator Marsh.

SPEAKER MARVEL: Senator Marsh.

SENATOR MARSH: Thank you, Mr. Speaker. The amendment is necessary because of the change of years. This was introduced last year. It must be updated. Patrick, do you want to read it?

SENATOR DeCAMP: Mr. President, since the committee amendments are nothing more than putting in four words that were left out by the bill drafter when the bill was drafted which coordinate with the rest of the bill, what I thought would be proper then would be to explain the whole bill or attempt to and deal with the whole bill rather than just deal with the amendment separately. LB 779 has several sections and several purposes and once again it was a bill introduced at the request of the Nebraska Bankers Association. It deals with matters in banking. As everybody knows, banks also need on occasions to borrow money to meet day to day reserve and other requirement. Okay, Section 1, in line 5, in other words, Section 1 of the bill eliminates a term called "rediscounts and bills payable". The reason this is eliminated is because it is obsolete and nonapplicable language and we substitute instead the modern language of "direct borrowing". Now this section broadens, so everybody understands, I am broadening the

CLERK: Senator Clark voting yes.

SENATOR CLARK: Have you all voted? Record the vote.
